Sir,

In producing herewith the arrested accused drivers namely (1) Sonu Kumar @ Murari (22) S/o Nityanand Ram of Sanctoria 09 No. Niche Dhawra, Ward No 105, PS - Kulti, Dist.- Paschim Bardhaman (driver of dumper No. WB 41D/1996), (2) Rabi Shaw (34) S/o Rajendar Shaw of Chinakuria 1/2 No PGPT Mess, PS - Kulti, Dist.- Paschim Bardhaman (driver of dumper No. WB 45/1886) and seized 02 (two) Nos. of dumper bearing Reg. No. WB 41D/1996 & WB 45/1886 loaded with approx total 1300 Cft. Sand. Fact of the case in brief is that on 19.06.2023 myself along with ASI Khudiram Bouri, C/386 Sibendu Sinha, C/685 Dilip Chhatait & C/847 Uttam Hazra all are Raghunathpur PS were performing Evening Mobile Duty on Purulia - Barakar road and at about 18:45 hrs. received a source information that the above noted dumpers loaded with sand were going towards Adra side. After receiving such information I informed the matter to IC Raghunathpur PS and as per his kind direction we had been to Raghunathpur - Adra road near at Raghunathpur Stadium and waiting for the said dumpers and at about 19:05 hrs found that the above noted dumpers are coming from Raghunathpur side. We stopped the said dumpers and on searching it is found that the said dumpers were loaded with sand and on asking drivers of the said dumpers failed to produce any papers in respect of loaded sand as well as papers in respect of the said dumpers. Both the drivers also made incoherent statements in respect of possession of the said sand in their respective dumpers which they were driving. So, it is reasonable to believe that the drivers and owners of those said dumpers collected the said sand either by theft or by any fraudulent means from anywhere and transporting the same to run clandestine business for wrongful gains as well as loss of Govt. revenue. On interrogation both the drivers of the said dumpers confessed their guilt. As such it is every reason to believe that both the drivers and owner of those dumpers bearing Reg. No. WB 41D/1996 & WB 45/1886 transporting sand illegally. As such I seized of those dumpers having registration No. WB 41D/1996 & WB 45/1886 loaded with approx 650 Cft. each as stolen sand under proper seizure list duly signed by the accused drivers. Arrange for measuring the sand loaded dumpers and collect the measuring slips. Also arrested both the accused drivers of above noted dumpers namely (1) Sonu Kumar @ Murari (22) S/o Nityanand Ram of Sanctoria 09 No. Niche Dhawra, Ward No 105, PS -Kulti, Dist.- Paschim Bardhaman and (2) Rabi Shaw (34) S/o Rajendar Shaw of Chinakuria 1/2 No PGPT Mess, PS - Kulti, Dist.- Paschim Bardhaman after observing all formalities and narrating them the ground of arrest. No public witness was available there. Approx 01 (One) K.G. of Sand each dumpers sealed & labeled as sample Sand from major contraband.

I therefore pray before you, kindly lodge an FIR against the accused drivers namely (1) Sonu Kumar @ Murari (22) S/o Nityanand Ram of Sanctoria 09 No. Niche Dhawra, Ward No 105, PS – Kulti, Dist.- Paschim Bardhaman and (2) Rabi Shaw (34) S/o Rajendar Shaw of Chinakuria 1/2 No PGPT Mess, PS – Kulti, Dist.- Paschim Bardhaman and owner of those dumpers bearing Reg. No WB 41D/1996 & WB 45/1886 as per law and arrange for its investigation.
