Sir,

In producing herewith the arrested accused persons namely (1) Swapan Murmu (38) S/o Lt. Balak Murmu of Vill.- Mohuda, PS - Para, Dist.- Purulia, (2) Jiten Gorai (58) S/o Lt. Gour Gorai of Vill.- Durmut, PS - Raghunathpur, Dist.- Purulia, (3) Bistu Gorai (48) S/o Lt. Sasankar Gorai of Vill.-Biltora, PS - Raghunathpur, Dist.- Purulia, (4) Partha Mandal (27) S/o Lt. Ashok Mandal of Vill.+PO - Aguibari, PS - Raghunathpur, Dist.- Purulia and (5) Aditya Mandal (60) S/o Lt. Panchanan Mandal of Vill.+PO - Aguibari, PS - Raghunathpur, Dist.- Purulia and seized 04 (Five) Nos. two wheelers. scooters without number plate loaded with coal approx 1 MT and approx 50 MTs coal from stock point which is situated inside the bush area of Swetpalash Jangle. Fact of the case in brief is that on 11.06.2023 myself along with C/847 Uttam Hazra, C/2461 Manas Gorai were performing special raid duty in Raghunathpur PS area vide Raghunathpur PS CC No. 1637/23. On 11.06.2023 at about 09:15 hrs. received a credible source information that some persons were carrying coal in two wheelers scooters for stocking at Swetpalash Jangle area under Raghunathpur PS with a view to illegal transporting from there. After receiving such information I informed the matter to IC Raghunathpur PS and as per his kind direction we reached near at Swetpalash Jangle. Then we have cordoned the place by our police personnel and found that some persons having loaded coal in two wheelers scooters were stocking point, at that time we were able to apprehend 05 (Five) Nos. of persons as noted above and 04 (Four) Nos. of coal loaded two wheelers scooters without number plate and also found coal near about 50 MTs were stocked inside the bush area of the said Swetpalash Jangle. On asking the above noted persons confesses their guilt that the two wheeler scooters riders were carrying coal from Kargali Ghat to deposit the coal at stock point of Swapan Murmu and others which is situated inside the Swetpalash Jangle under Raghunathpur PS and Swapan Murmu (38) S/o Lt. Balak Murmu of Vill.- Mohuda, PS - Para, Dist.- Purulia disclosed that he along with Rinku Kumbhakar S/o Dinu Kumbhakar and Swapan Hazra S/o Sachinath Hazra both of Kargali, PS - Raghunathpur, Dist.-Purulia illegally transporting the same to run clandestine business for wrongful gains with the help of others since long. They also made incoherent statements in respect of possession of the said huge quantity of coal. So, it is reasonable to believe that the rider of those two wheelers scooters collected the said coal either by theft or by any fraudulent means from anywhere and depositing the said coal at stock point of Swapan Murmu, Rinku Kumbhakar and Swapan Hazra. Thereafter they illegally transporting the same to run clandestine business for wrongful gains with the help of others. I seized

the above 04 (Four) Nos. of coal loaded two wheelers scooters without number plate and near about 50 MTs which were stocked inside the bush of the said Swetpalash Jangle. I also arrested the above noted accused persons after observing all formalities and narrating their ground of arrest. No public witnesses were turned up there. Approx 01 (One) K.G. of Coal in each two wheelers scooters and 01 KG of Coal from stock point collected as sample coal.

I therefore pray before you, kindly lodge an FIR against the arrested accused persons namely (1) Swapan Murmu (38) S/o Lt. Balak Murmu of Vill.- Mohuda, PS – Para, Dist.- Purulia, (2) Jiten Gorai (58) S/o Lt. Gour Gorai of Vill.- Durmut, PS – Raghunathpur, Dist.- Purulia, (3) Bistu Gorai (48) S/o Lt. Sasankar Gorai of Vill.- Biltora, PS – Raghunathpur, Dist.- Purulia, (4) Partha Mandal (27) S/o Lt. Ashok Mandal of Vill.+PO - Aguibari, PS – Raghunathpur, Dist.- Purulia and (5) Aditya Mandal (60) S/o Lt. Panchanan Mandal of Vill.+PO - Aguibari, PS – Raghunathpur, Dist.- Purulia, (6) Rinku Kumbhakar S/o Dinu Kumbhakar, (7) Swapan Hazra S/o Sachinath Hazra both of Kargali, PS – Raghunathpur, Dist.- Purulia and others unknown as per law and arrange for its investigation.
