I, Sudhir Tudu S/o- Lt. Jagannath Tudu of Vill- Tarpania, P.O- Ranga, PS- Bagmundi, Dist-Purulia, ASI of Police, of Tamna PS, Dist- Purulia as ASI of Police producing herewith one arrested accused person namely Ranjit Rajwar (35 yrs) S/O- Lt. Hafis Rajwar of Vill- Gobindapur, P.S- Tamna, Dist-Purulia with seized articles i.e. 1). One white colour plastic jerican containing approx 18 Ltrs. of ID Liquor, 2) 05 pieces plastic glass, 3) One Plastic Bottle containing 1 Ltr. ID liquor as sample which was collected from seized articles Sl No-01 which were seized under proper seizure list.

I beg to submit that today (16.06.2023) during my evening mobile duty received secret source information that one person selling I.D Liquor at Gobindapur morh under Tamna PS, Dist-Purulia, so I along with i) C/2452 Tapas Pal & ii) C/2686 Ranabir Patra both of Tamna PS came to the spot at about 19:25 hrs and found that one person is selling I.D Liquor to the others. Seeing the Police party, all customers fled way but we managed to apprehend one person. On being asked he disclosed his identity as Ranjit Rajwar (35 yrs) S/O- Lt. Hafis Rajwar of Vill- Gobindapur, P.S- Tamna, Dist- Purulia and he is selling ID liquor in his shop "Ramesh Varity store" at Gobindapur morh, PS-Tamna, Dist-Purulia. On demand he failed to produce any valid licence /documents in respect of storing and selling of ID liquor. As such I seized 1). One white colour plastic jerican containing approx 18 Ltrs. of ID Liquor, 2) 05 pieces plastic glass, 3) One Plastic Bottle containing 1 Ltr. ID liquor as sample collected from seized articles from SI No-01 which were seized under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in presence of witnesses. I also arranged to inform his family member about his arrest by police.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Ranjit Rajwar (35 yrs) S/O- Lt. Hafis Rajwar of Vill- Gobindapur, P.S- Tamna, Dist- Purulia as per proper section of law.
