In producing here with 02 (Two) arrested accused namely (1) Saroj Chakraborty (42 yrs) S/O Sudhangshu Chakraborty of Vill-Barabagan Mandal Para, (2) Santanu Bauri (28 Yrs) S/O Lt. Swapan Bauri of Vill-Barabagan Tanti Kuli, PS-Adra, Dist-Purulia along with following seized articles with seizure list and Memo of Arrest.

- (1) 21 (Twenty one) bottles of MC Dowell's No-1, 180 MI. each bottles Rs- 170/- each bottles
- (2) 04 (Four) bottles of Blender Pride 180 MI. Rs- 280/- of each bottle
- (3) 02 (Two) bottles of MC Dowell's No-1, 375 MI. Rs- 330/- each bottles
- (4) 04 (Four) bottle of IMPERIAL BLUE, 750 MI. Rs-640/- each bottles
- (5) 01 (One) bottle of ICONIQ WHITE, 750 MI. Rs-640/- of each bottle
- (6) 04 (Four) bottle HAYWARDS BEER, 650 MI. Rs-125/- of each bottle
- (7) 76 (Seventy Six) bottles DIL KHUSH country spirit, 600 MI. each Rs/-55 of each bottle.


I SI Madan Chandra Supakar of Adra PS do here by lodged a complaint against above noted accused to the effect that today i.e. 15/07/2023 in course of my special evening mobile duty as per order vide Adra PS CC No-1935/23 dtd.15.07.23 I received information from a reliable source at about 18:25 hrs that two Saroj Chakraborty and Santanu Bauri is selling foreign liquor and country spirit illegally inside a Jhopri near Railway Power House of Kamlasthan, PS-Adra, Dist-Purulia. After getting such information I informed to I/C Adra P.S. over phone and as per his direction I along with accompanied force reached in a Jhopri near Railway Power House of Kamlasthan at about 18:45 hrs and held raid in a Jhopri near Railway Power House of Kamlasthan and found that the above noted accd. Person selling foreign liquor and country spirit in a Jhopri near Railway Power House of Kamlasthan and after seeing the Police party, all the person fled away and said 02 Saroj Chakraborty and Santanu Bauri has tried to conceal themselves but we able to apprehend them. I asked them to produced valid License or valid papers in respect of selling of country spirit and foreign liquor but they failed to produce any valid license or documents in respect possessing /selling the same. So it is sufficient reason to believe that above said 02 Saroj Chakraborty and Santanu Bauri engaged to sale the country spirit and foreign liquor by illegal way. So I seized the above mentioned country spirit and foreign liquor under proper seizure list duly sign by accused persons and available witnesses. I also collected sample from seized country spirit duly sealed and labeled by me. There after I arrest the above mentioned accused persons informing them the ground of arrest. The complete process was done in between 19.05 hrs to 19.35 hrs.

I therefore pray that a specific case may kindly be start against arrested accused (1) Saroj Chakraborty (42 yrs) S/O Sudhangshu Chakraborty of Vill-Barabagan Mandal Para, (2) Santanu Bauri (28 Yrs) S/O Lt. Swapan Bauri of Vill-Barabagan Tanti Kuli, PS-Adra, Dist-Purulia under proper section of law.
