In producing here with 02 (Two)arrested accused namely (1) Binod Singh (35 yrs) S/O Kanta Singh of Lower Jhariadih Adra (2) Sajal Bauri (39 Yrs) S/O Surja Bauri of Vill-Barabagan, PS-Adra, Dist-Purulia along with following seized articles with seizure list and Memo of Arrest.

(1) 21 (Twenty One) bottle IMPERIAL BLUE 180 Ml. each bottle Rs-180/- of each bottle

(2) 04 (Four) bottles of OLD MONK 180 MI. Rs- 150/- of each bottle

(3) 03 (Three) bottle of MC Dowell's No-1, (XXX RUM) 375 MI. Rs-290/- of each bottle

(4) 01 (One) bottle of 100 Pipers Deluxe, 750 Ml. Rs-1880/-

(5) 02 (Two) bottle of Sterling Reserve (B7), 750 Ml. Rs-750/- of each bottle (6) 01 (One) bottle Blender Pride (reserve), 750 Ml. Rs-1190/- of each bottle

(7) 90 (Ninety) bottles DIL KHUSH country spirit, 600 Ml. each Rs/-55 of each bottle

I SI Dipak Kumar Pandey of Adra PS do here by lodged a complaint against above noted 02 accused to the effect that today i.e. 15/07/2023 in course of special evening mobile duty as per order vide Adra PS CC No-1936/2023 dtd.15.07.23. I received information from a reliable source at about 18:40 hrs that two Binod Singh and Sajal Bauri are selling country spirit illegally and foreign liquor in a Jhopri at Jyoti More. After getting such information I informed to I/C Adra P.S. over phone and as per his direction I along with accompanied force reached in a Jhopri at Jyoti More at about 18:55 hrs and held raid in a Jhopri at Jyoti More and found that the above noted accd. Persons selling country spirit and foreign liquor in a Jhopri at Jyoti More and after seeing the Police party, all the person fled away and said 02 Binod Singh and Sajal Bauri has tried to conceal themselves but we able to apprehend them. I asked them to produced valid License or valid papers in respect of selling of country spirit and foreign liquor but they failed to produce any valid license or documents in respect possessing /selling the same. So it is sufficient reason to believe that above said Binod Singh and Sajal Bauri engaged to sale the country spirit and foreign liquor by illegal way. So I seized the above mentioned country spirit and foreign liquor under proper seizure list duly sign by accused persons and available witnesses. I also collected sample from seized country spirit duly sealed and labeled by me. There after I arrest the above mentioned accused person informing them the ground of arrest. The complete process was done in between 19.05 hrs to 19.35 hrs.

I therefore pray that a specific case may kindly be start against arrested accused (1) Binod Singh (35 yrs) S/O Kanta Singh of Lower Jharadih Adra (2) Sajal Bauri (39 Yrs) S/O Surja Bauri of Vill-Barabagan, PS-Adra, Dist-Purulia under proper section of law.
