Sir,

In producing here with 02 (Two) arrested accused namely (1) Rakesh Verma (38 yrs) S/O Surendra Verma of Vill-Kamlasthan, (2) Sudan Meta (24 Yrs) S/O Lt. Sahadeb Meta of Vill-Arrah (Meta Kuli) PS-Adra, Dist-Purulia along with following seized articles with seizure list and Memo of Arrest.

- (1) 09 (Nine) bottles of ROYAL STAG, 180 MI. each bottles Rs- 210/- each bottles
- (2) 16 (Sixteen) bottles of MC Dowell's No-1 (XXX RUM), 180 MI. Rs- 150/- each bottles
- (3) 04 (Four) bottles of MC Dowell's No-1, 750 MI. Rs- 640/- each bottles
- (4) 02 (Two) bottle of IMPERIAL BLUE, 375 MI. Rs-330/- each bottles
- (5) 01 (One) bottle of Royal Stag (Whisky), 750 MI. Rs-740/-
- (6) 04 (Four) bottle Blender Pride, 750 MI. Rs-980/- of each bottle
- (7) 18 (Eighteen) bottle TUBURG BEER, 650 MI. Rs-125/- of each bottle
- (8) 01 (One) bottle BUDWEISER BEER, 650 MI. Rs-150/-
- (9) 25 (Twenty Five) bottles CAPTAIN country spirit, 600 MI. each Rs/-155 of each bottle.

I ASI Ajay Kumar Mandal of Adra PS do here by lodged a complaint against 02 above noted accused to the effect that today i.e. 15/07/2023 in course of evening mobile duty as per order vide Adra PS CC No- 1934/23 dtd.15.07.23. I received information from a reliable source at about 20:35 hrs that two Rakesh Verma and Sudan Meta are selling country spirit illegally and foreign liquor in a Jhopri inside of Adra Bus Stand. After getting such information I informed to I/C Adra P.S. over phone and as per his direction I along with accompanied force reached in a Jhopri inside of Adra Bus Stand at about 20:55 hrs and held raid in a Jhopri inside of Adra Bus and found that the above noted accd. Person selling country spirit and foreign liquor in a Jhopri inside of Adra Bus and after seeing the Police party, all the person fled away and said 02 liquor in a Jhopri inside of Adra Bus and after seeing the Police party, all the person fled away and said 02 Rakesh Verma and Sudan Meta has tried to conceal themselves but we able to apprehend them. I asked them to produced valid License or valid papers in respect of selling of country spirit and foreign liquor but they failed to produce any valid license or documents in respect possessing /selling the same. So it is sufficient reason to believe that above said Rakesh Verma and Sudan Meta engaged to sale the country spirit and foreign liquor by illegal way. So I seized the above mentioned country spirit and foreign liquor under proper seizure list duly sign by accused person and available witnesses. I also collected sample from seized country spirit duly sealed and labeled by me. There after I arrest the above mentioned accused person informing him the ground of arrest. The complete process was done in between 21.05 hrs to 21.55 hrs.

I therefore pray that a specific case may kindly be start against arrested accused (1) Rakesh Verma (38 yrs) S/O Surendra Verma of Vill-Kamlasthan, (2) Sudan Meta (24 Yrs) S/O Lt. Sahadeb Meta of Vill-Arrah (Meta Kuli) PS-Adra, Dist-Purulia under proper section of law.
