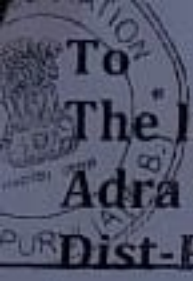

Producing here with one arrested accused namely (1) Jogesh Bauri (64 Yrs) S/O Lt. Nitai Bauri of Vill-Palashkola, (2) Rohan Choudhury (40 Yrs) S/O Lt. Ram Dhanu Choudhury of Vill-Doulatpur, (3) Dipak Bauri (48 Yrs) S/O Lt. Budhu Bauri of Vill-Childrenpark, PS-Adra, Dist-Purulia along with following seized articles with seizure list and Memo of Arrest.

- 1) 20 (Twenty) bottles DIL KHUSH country spirit, 600 Ml. each Rs/-55 of each bottle
- 2) 04 (Four) bottles DIL KHUSH country spirit, 375 Ml. each Rs/-35 of each bottle
- 3) 03 (Three) bottles DIL SE country spirit, 600 Ml. each Rs/-55 of each bottle
- 4) 05 (Five) bottles CAPTAIN country spirit, 600 Ml. each Rs/-155 of each bottle out of them one bottle of country spirit taken from Sl. No. 1,2,3,4, duly sealed and labeled as sample.

SI Madan Chandra Supakar of Adra PS do here by lodged a complaint against the above noted accused persons namely (1) Jogesh Bauri (64 Yrs) S/O Lt. Nitai Bauri of Vill-Palashkola, (2) Rohan Choudhury (40 Yrs) S/O Lt. Ram Dhanu Choudhury of Vill-Doulatpur, (3) Dipak Bauri (48 Yrs) S/O Lt. Budhu Bauri of Vill-Childrenpark, PS-Adra, Dist- Purulia to the effect that on 26/07/2023 at about 18:35 hrs I received a telephonic information from a reliable source during my evening mobile duty at P.S area vide Adra PS CC NO-2055/23 dtd.26/07/23 that the above noted accused persons has been stock of country spirit illegally at their Jhupri at Adra Bus Stand. After getting such information I informed to my I/C and as per his direction I along with my accompanied force reached at Adra Bus Stand at about 18:55 hrs and hold raid in the Jhupri of above noted accused persons and found that the said persons selling liquor at their Jhupri and after seeing the Police party some person fled away and said above noted accused persons has tried to concealed themselves but I able to apprehend them with the help of accompanied force and also detained them. I asked them to produced valid License or valid papers for selling country spirit but they failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that the above noted accused persons selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused persons and available witnesses and arrested the above mentioned accused persons informing the ground of arrest. The complete process was done in between 19.05 hrs to 19.55 hrs.

Wants I there for pray that a specific case may kindly be started against arrested accused persons namely (1) Jogesh Bauri (64 Yrs) S/O Lt. Nitai Bauri of Vill-Palashkola, (2) Rohan Choudhury (40 Yrs) S/O Lt. Ram Dhanu Choudhury of Vill-Doulatpur, (3) Dipak Bauri (48 Yrs) S/O Lt. Budhu Bauri of Vill-Childrenpark, PS-Adra, Dist- Purulia under proper section of law.
