Sir.

In producing herewith the arrested accused persons namely (1) Naran Mandal (54 Yrs) S/O Lt. Amulya Mandal of Vill-Beko (2) Sunit Bauri (50 Yrs) S/O Lt. Nitai Bauri (3) Trilochan Bauri (37 Yrs) S/O Lt. Surendranath Bauri both of Vill-Ranguni, PS-Adra, Dist- Purulia before you, along with seized articles like board money amounting to RS- 4610/-, 52 nos of playing cards, one burned candle, one plastic sheet from their possession as per seizure list.

I beg to report that on 28.07.2023 at 21:05 hrs, I received secret information that one gambling with huge amount was going on in a abandoned Rly. Quarter at Children Park, South side Adra during my special mobile duty. Accordingly I inform to I/C Adra PS and as per his direction I along with (1) C/958 Subhas Bauri (2) C/285 Arup bagdi (3) C/1272 Bikash Ch. Patra in Govt. vehicles left for Children Park to work out the information. At about 21:35 hrs we reached at the said place slowly and cautiously approached towards abandoned Rly, quarter where the gambling was reportedly going on. After that I asked my associate staffs to cordon the place and within a moment the place was cordoned by Police party. From the inside of the abandoned Rly, quarter we over heard the talking of persons present there. On reasonable doubt we entered inside the said abandoned Rly, quarter and saw that 02/03 persons were immediately fled away from the room on seeing police party. We disclosed our identity and we were able to apprehend the above noted persons. Then, I requested them to search myself and my other staff accordingly the persons searched ourselves and found nothing except wearing apparels (Police Uniform with nameplates) and Mobile Phones. After that we asked their identity and the persons disclosed their name and address as noted above. It was found that a huge amount of currency note of different denomination were kept on gaming board (One plastic sheet on the floor) and playing cards were also found. On demand the persons clearly confessed that all of them were doing gambling with playing cards in exchange of cash for wrongful loss to one and wrongful gain to another. After that in presence of police party the board money of Rs 4610/- (Four Thousand Six Hundred and Ten Rupees) with different denomination, 52 nos of Playing cards and one plastic sheet, one burn candle were seized for the gaming board in between 21:55 hrs to 22:25 hrs under proper seizure list duly signed by police witnesses as the place is lonely so I found no public witness. On interrogation they also stated that (1) Arvind Sharma S/O Lt. Anandi Sharma of Vill-Kamlasthan, PS-Adra, Dist-Purulia and (2) Chaitan Bauri of Vill-Ranguni were also doing gambling with playing eards with them on seeing police party they were fled away, Accordingly I arrested the apprehended 03 accused persons issuing arrest memo at 16.35 hrs to 29.45 hrs. After arrest I offered them medical treatment but they denied.

Therefore I pray before you that for committing offence punishable u/s- 3 & 4 of W.B.G & P.C Act a specific case may kindly be started against all the above noted 05 (Five) persons & others and
