To The Inspector- in – charge of Adra P.S Dist. - Purulia

Sir,

In producing herewith one seized fire arms with body, barrel and trigger seized from the roadside bushy place near Shantidham Bridge as shown and identified by police remand accused Md. Jamal (52 Yrs) S/O Lt. Allauddin of Adra SBI Para, Lower Beniasol, PS- Adra Dist- Purulia. I SI Mekdam Sabab of Adra P.S hereby lodge a complaint against the above noted accd. person to the effect that on 23/06/2023 I took up investigation of Adra PS Case No. 51/2023 Dt. 23.06.2023 U/S 302/307/120B/34 IPC & 25/27/35 Arms Act. In that case, the complainant Ananda Chowbey alleged that on 22/06/23 at about 19.25 hrs to 19. 30 hrs his brother Dhananjay Chowbey was murdered by some unknown miscreants from gunshot injury in front of party office at Adra Pandey Market, P.S- Adra, Dist.-Purulia.

In course of investigation, I arrested the above noted accd. person Md. Jamal and then he was taken into police remand for 13 (Thirteen) days. During remand period I interrogated him and after interrogation he confessed his guilt stating that he along with others accd. persons committed the murder after gunshot injury he also confessed that the gun which he used in the murdered of Dhananjay Chowbey was hidden in Adra Kashipur roadside bush near Shantidham Bridge under Adra PS.

As per his leading statement I along with force and the PC accused Md. Jamal left for working out the information and we reached the place along with PC accused. In the mean time 02 persons namely 1) Sourav Tewari, S/o- Alok Tewari of Vill- Beliadanga, PS- Kashipur, Dist- Purulia and 2) Kamal Mandal, S/o- Nepal Mandal of Vill- Pabra, PS- Kashipur, Dist- Purulia were coming from Kashipur side then I stopped them and requested to be witness during the process of searching and they agreed. As per identification of the PC accused 1 along with force searched the said area in presence of the witnesses and found an iron-made, steel-colored pistol (firearm) having total diagonal length of approximately 20.5 em, with a body measuring approximately 14.5 centimeters long from barrel head to hammer, barrel approximately 10 centimeters long, butt approximately 9.5 centimeters long, magazine approximately 10.5 centimeters long by 2.5 centimeters wide, there is a engraved marked on one side of the magazine and NO 15 is written on the bottom side of magazine. MADE IN USA NO 15 is written on one side of the pistol and 7.65 1 ROUND on another side and ONLY FOR SUPLAY is written on the barrel kept in a plastic packet as shown and identified by him. During interrogation he also confessed that he used the said fire arms to shot Dhananjay Chowbey for committing murder at the time of incident. On questioning he failed to produce any valid document against the fire arms. Accordingly I seized the fire arms as per seizure list duly singed by the witnesses. I also labeled the alamat in the spot. The whole process i.e. Search, Seizure, and arrest is done on 05.07.23 at 19.45 hrs to 20.45 hrs.

As such he is liable for punishable offence. It is a fact that the deceased Dhananjay Chowbey was murdered with gunshot injury and the accd person used fire arms for this purpose. This seized fire arms may not be used to commit crime in C/W Adra PS Case No. 51/2023 Dt. 23.06.2023 U/S 302/307/120B/34 IPC & 25/27/35 Arms Act. So, I am submitting this complaint against Md. Jamal (52 Yrs) S/O Lt. Allauddin of Adra SBI Para, Lower Beniasol, PS- Adra Dist- Purulia to start a specific case under proper section of law and to arrange for its investigation.
