Sir,

In producing here with one arrested accused person Raju Bauri (30Y) S/O Lt. Kanai Bauri of vill- Uparjambad, PS- Arsha, A/P resided at Vill- Manpur, P.S.-Arsha Dist-Purulia along with following seized articles.

1) One white colour plastic container containing approx 16 ltrs. of ID liquor.
(Approx 500 ml taken out from of the above container as sample packed with sealing wax)

I, SI Anirban Dutta of Arsha PS do hereby lodge a typed complaint against the above noted accused person to the effect that today i.e 27.07.2023 at about 19.45 hrs. during my mobile duty at Naya morh under Arsha PS, received source information over telephone that the above noted accused has been selling ID liquor in his house at Manpur village. On receiving the source information, I communicated with O/C Arsha PS over telephone and as per his direction I along with C/- 1140 Dayamay Mahato of Arsha PS and C/- 315 Joydeb Gorain of SAP 7th BN present camp at Arsha PS, rushed to the house of above noted accused person to work out the information vide Arsha PS C.C. No. 1860/23 dtd- 27.07.2023. Reaching at Manpur village at about 20.25 hrs. We fixed-up in the house of Raju Bauri (30Y) S/O Lt. Kanai Bauri of vill- Uparjambad, PS- Arsha, A/P resided at Vill- Manpur, P.S.-Arsha Dist-Purulia and found that selling of ID Liquor was going on there and having seen police all customers managed to escape, but we were able to apprehended the above noted accused person who was selling ID liquor. On demand he failed to produce any valid documents in support of selling ID liquor. So I seized one white colour plastic container containing approx 16 ltrs. of ID liquor under a proper seizure list from his possession in presence of witnesses, properly sealed and labeled it duly signed by the accused person and witnesses out of which approx 500 ml was taken out from the above container as sample packed with sealing wax and labeled it. During interrogation he confessed his guilt. So, I arrested him after observing all the formalities issuing memo of arrest as he was selling ID liquor illegally.

I therefore, pray that a specific case may kindly be started against the accused person namely Raju Bauri (30Y) S/O Lt. Kanai Bauri of vill- Uparjambad, PS- Arsha, A/P resided at Vill- Manpur, P.S.-Arsha Dist-Purulia under proper section of law.
