With due respect, I want to inform you that my brother namely Nishit Ranjan Mahato S/O Ramesh Chandra Mahato of Vill+P.O.- Uparbatri, PS- Kotshila, Dist- Purulia (W.B) was an ASI/GD. F/No.065101109 in BN/167 C.R.P.F and was currently posted at Patharbandh Camp, under Balarampur P.S Dist.- Purulia (W.B). On 28.06.2023, he got information that his daughter was seriously ill. In that respect he was granted 02 (two) days leave and was going to his house at Purulia by his motorcycle vide No. WB56J/7762 (Bajaj Pulsar). At around 19.15 hrs, one truck vide Reg. No. JH09AP/1095 dashed him which was being driven negligently and rashly near Kourang Jungle under Arsha P.S. He received injuries and was taken to Purulia Hospital by the locals. But the attending Doctor declared him brought dead. The motorcycle too got completely damaged. This is to inform you that one U/D case was started at Purulia (T) P.S vide Purulia (T) P.S U/D Case No. 222/23 Dtd. 28.06.2023.

On the above circumstances, I pray to you to kindly lodge an FIR for proper investigation.
