Koderma, District -Koderma, Jharkhand- 825409, .My husband Mohammad Samim Ansari was the Registered Owner of heavy vehicle bearing Registration No.-CG 07CA/6191 (Trailer) and my husband was also driver of the said vehicle. On 03.7.2023 my said husband was driving the said Trailer and was coming from TATA to Purulia and an another Truck number is not known was coming before the Trailer while the Trailer and another truck reached in between Koran and Katadih at about 5 A.M. Morning the Driver of unknown truck suddenly bracked the truck as a result which the said Trailer Dashed the unknown truck. ,as a result which the my husband Mohammad Samim Ansari received multiple injuries and soon after, the injured shifted to Purulia Deben Mahato Sadar Hospital, Purulia and my husband Mohammad Samim Ansari expired there on the same day. The incident took place due to rash and negligent Driving of the Driver of unknown Truck.

So, I pray that necessary lawful steps be taken against the unknown Truck and the Driver.
