Subject: Prayer for starting a specific case against Ashok Mitra (59 Yrs), S/O-Lt-Nityananda Mitra of Vill+P.O+PS-Baghmundi, Dist-Purulia

Sir,

In producing here with one arrested accused person namely Ashok Mitra (59 Yrs), S/O-Lt-Nityananda Mitra of Vill+P.O+PS-Baghmundi, Dist-Purulia along with following seized articles viz-

1. 15 Ltrs (Approx) of country spirit contained in a container.
2. One plastic packet containing NISHADAL weighing 200 gms.
3. 05 pieces of plastic glass.

I beg to submit that today on 30.06.2023 at about 18:45 hrs, during my mobile duty as per Baghmundi PS C.C No- 2040/23 & Baghmundi PS GDE No-1292, Dtd: 30.06.2023 received source information that one person has stocked some illicit liquor at Baghmundi village (Nirupama Hotel) under Baghmundi P.S & selling the same to innocent people for their personal gain. Accordingly I informed the matter to O/C Baghmundi PS & as per order, I ASI Bipadaran Chatterjee along with force (1) C/778 Sanjay Chowdhury (2) C/765 Lalmohan Murmu of Baghmundi PS, Dist-Purulia held raid at Nirupama Hotel under Baghmundi village (as shown by source) at about 19:05 hrs and found that one person was preparing the country spirit illicit liquor by mixing some intoxicated substance (like white powder) having acrid smell which is likely to cause disability or death to human being, behind the hotel. Accordingly I detained the person who recognized himself as Ashok Mitra (59 Yrs), S/O-Lt-Nityananda Mitra of Vill+P.O+PS-Baghmundi, Dist-Purulia. Being interrogated he confessed that the white powder like substance is NISHADAL, an intoxicated substance having acrid smell which is likely to cause disability or death to human being. It is also revealed during interrogation that above noted person usually prepares the illicit liquor mixing with NISHADAL for selling. On demand he failed to produce any valid document from competent authority in respect of preparing, stocking and selling of ID liquor. So, I arrested the above mentioned accused person namely Ashok Mitra (59 Yrs), S/O-Lt-Nityananda Mitra of Vill+P.O+PS-Baghmundi, Dist-Purulia maintaining all guidelines of the Apex Court of India & NHRC regarding arrest and seized the above mentioned articles in between 19:25 hrs to 19:45 hrs after preparing proper seizure list duly signed by the witnesses.

Under the fact and circumstances, I therefore pray before you a specific case may kindly be started against the above noted accused person under proper section of law and arrange its investigation.
