**Sub:** Complaint against Biswanath Majhi (26 Yrs/Male) S/o Buka Majhi of Vill-Panjanbera, PO-Raigara, PS- Barabazar, Dist- Purulia to start a specific case as per law.

Sir,

In producing here with one arrested accused person namely Biswanath Majhi (26 Yrs/Male) S/o Buka Majhi of Vill-Panjanbera, PO-Raigara, PS- Barabazar, Dist- Purulia along with Memo of arrest, Seizure List and seized article i.e- one Plastic Jarakin containing approx 19 (Nineteen) liters of I.D liquors (Cholai) and taken 500 ml ID Liquor (Cholai) as sample.

I, ASI Jaydip Mukherjee of Barabazar PS do here by lodge this complaint against one Biswanath Majhi (26 Yrs/Male) S/o Buka Majhi of Vill-Panjanbera, PO-Raigara, PS- Barabazar, Dist- Purulia that on 13.07.2023 during my evening mobile duty vide Barabazar PS GDE No- 766 Dtd. 13.07.2023 received a source information that one person unauthorized selling I.D liquor (Cholai) in his house at Panjanbera village under Barabazar PS, Dist- Purulia. I have been then verified the credibility of that information and as per direction of I.C Barabazar PS myself along with force had been to Panjanbera village to work out the information. At about 20.25 hrs found one person was selling I.D liquor (Cholai). When we reached near his house, then seeing the Police party, customers were fled away. During search with the help of my accompanying force, we found that the said person is stocking Plastic Jarakin containing approx 19 (Nineteen) liters of I.D liquors (Cholai) and selling from there. However, I apprehended him and on demand, he failed to produce any valid documents/ License in respect of selling and keeping of I.D liquors. On being asked he confessed his guilt and stated that he selling the ID liquor (Cholai) with intent to sell to make own profit. He disclosed his identity as noted above & also admitted that he had no license or any authorization to carrying and selling of ID Liquor. Accordingly, I seized the above noted article after preparing a proper seizure list and put label on the seized article in presence of witnesses and 500 ml of I.D liquor (Cholai) taken as sample from the mother contraband as sample which was also duly labeled and also took signature of the accompanying witnesses as well as accused person on seizure list and label also.

Thereafter, I secured arrest of the accused person namely Biswanath Majhi (26 Yrs/Male) S/o Buka Majhi of Vill-Panjanbera, PO-Raigara, PS- Barabazar, Dist- Purulia after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guide line. Informed him and his relatives regarding the ground of arrest.

Under the above fact & circumstances I, therefore, pray before you that a specific case may kindly be registered against the aforesaid accused and also to arranging for its investigation.
