Sir,

In producing herewith one arrested accused namely Ardhendu Tudu (48) S/o Surya Kanta Tudu of Sasandih, PS Barabazar, Dist Purulia out of two and one arrested accused person namely Pintu Das Goswami (23) S/o Bhriguram Das Goswami of Vill-Sarberia, PS Barabazar, Dist Purulia who is under treatment at Barabazar BPHC and referred him to DMGMC&H Purulia for better treatment, Two seizure list, Two Memo of Arrest , Two inspection Memo, and the seized articles i.e.-

- One improvised country made one Sutter pipe gun, length about 22 cm, butt about 8.5 cm (wooden), barrel 13cm bore 1 cm marked as exhibit "A".
- 2. One round of 8 mm K.F cartridge, ,length 7.5 cm marked as exhibit "B"

I ASI Partha Sarathi Bose of Barabazar PS, Dist- Purulia do hereby lodged this complaint against i)Pintu Das Goswami (23) s/o Bhriguram Das Goswami of Vill- Sarberia PS Barabazar Dist Purulia & ii)Ardhendu Tudu (48) s/o Surya Kanta Tudu of Sasandih, PS Barabazar Dist Purulia to the effect that today on 28/07/23 myself along with C/347 Manas Pathak and C/677 Syed Julhar Ali were performing Mobile duty vide CC No-3174/23 dt 28/07/23, GDE No- 1724 dt 28/07/23 with Govt vehicle bearing Registration No- WB 26K/5475 and at about 15.38 hrs when we were performing mobile duty near Sindri Bazar area received an information from Duty officer ASI Jaydip Mukherjee, informed me that two persons were moving suspiciously carrying with Arms near Sasangdih Football Math and also informed me to work out the information. The matter was diarized vide GDE No-1747,1748 Dtd.28/07/23 by ASI Jaydip Mukherjee. As per direction of LC Barabazar PS myself along with accompanied force rushed to the spot at about 16.05 hrs, found people gathered there. We kept the vehicle beside the side of Football Math at Sasangdih. We reached there found that two persons were detained by the people and one of them received injury by manhandled.

I asked their identity. They disclosed their identity as i)Pintu Das Goswami (23) s/o Bhriguram Das Goswami of vill-Sarberia PS Barabazar Dist Purulia & ii)Ardhendu Tudu (48) s/o Surya Kanta Tudu of Sasandih PS Barabazar Dist Purulia. Interrogated them then they told they are possessing and ammunition. Then myself called two following persons namely (i) Bhakta Ranjan Hembram S/o Jaladhar Hembram of Sasandih, PS-Barabazar, Dist-Purulia & (ii) Jaladhar Murmu S/o Sasticharan Murmu of Hatnadih, PS-Barabazar, Dist-Purulia as witnesses. Asked them to search Police Party but they refused. Searched them properly and found One improvised country made one Sutter pipe gun, kept left side waist under pant of one Pintu Das Goswami s/o Bhriguram Das Goswami of vill-Sarberia PS Barabazar Dist Purulia and one life cartridge right side shirt 's pocket of Ardhendu Tudu s/o Surya Kanta Tudu of Sasandih PS Barabazar Dist Purulia. Removed the same and taking measuring of improvised country made one Sutter pipe gun, length about 22 cm, butt about 8.5 cm (wooden), barrel 13 cm bore 1 cm marked as exhibit "A" & One round of 8 mm K.F cartridge, Length 7.5 cm marked as exhibit "B". Seized the same under proper seizure list and labeled. On being asked they confessed their guilt and told that they possessed the fire arms and ammunition to commit crime and failed to produce any valid document / papers regarding carrying / possession the Arms and ammunition.

Porthe Somathi Box ase

The process of seizure took place in between 16:15 hrs and 16:45 hrs then arrested them after obtaining all rules of arrest at 16.55 hrs. Issued memo of arrest, Inspection Memo. Informed them regarding the ground of arrest.

Held a local enquiry in and around the P.O to collect further information about the culprits. Then we left the place with two arrested accused persons, seized articles for Barabazar BPHC. On duty MO treated and referred one Pintu Das Goswami to DMGMC&H Purulia for better treatment. I directed C/347 Manas Pathak to guard him and left for PS to take further actions as per provision of law with one arrested accused and seized articles.

I came to PS, prepared this letter of complaint and submitted it to I.C Barabazar through duty Officer to start a case under proper section of law against the arrested accused i) Pintu Das Goswami (23) S/o Bhriguram Das Goswami of Vill- Sarberia, PS- Barabazar, Dist Purulia & ii) Ardhendu Tudu (48) S/o Surya Kanta Tudu of Sasandih, PS- Barabazar, Dist Purulia.
