

In producing here with 02 accused persons namely (1) Abdul Rahaman SK (26 yrs) S/o-Balu SK of Vill-Pakhanna PS-Borjora Dist-Bankura (Driver of Truck No-WB33C-5775) (2) Arif Bhangi (21 yrs) S/o-Sariph Ali Bhangi of Vill-Methiadahar PS-Gorbetha Dist-Paschim Medinipur (Helper of No-WB33C-5775) along with seized articles i.e. 01 (one) Truck having Registration No-WB33C-5775 loaded with approx 25 TN coal, also taken sample of 05 kg from the Truck, to the effect that I, SI Sanjay Diger along with C/-992 Sanjoy Bauri C/-857 Chepulal Murmu both of Joypur PS Dist-Purulia vide CC No-1669/23 Dated-24/07/2023 were engaged in special mobile duty near Dumurdih Rail gate on Purulia-Ranchi Pitch Road (SH-4A) under Joypur PS Dist-Purulia and found the above noted Truck was coming from Jhalda side via Joypur towards Purulia. On seeing the Police party the above noted accused persons stopped the Truck was loaded with huge quantity of illegal coal, they tried to fled away. After hot chase we abled to apprehended 02 persons. On being asked they disclosed their name and address as noted above. On interrogation they stated that they will sell illegal coal to the local people at any place of Purulia District. On demand he failed to produce any valid papers in respect of possessing on selling of coal. So, it is reasonable to believe that the driver, helper & owner of the above noted Truck collected the said coal either by theft or by any other fraudulent means from anywhere and transporting the same to earn money for wrongful gains. As such, there is every reason to believe that the above noted Truck transporting coal illegally. So, I seized the same under proper seizure list in between 12:05 hrs to 12:15 hrs on 24/07/2023 & label duly signed by

s after taking sample of 05 kg coal from the Truck. During further interrogation they confessed their guilt as such I arrested them today at 12:20 hrs to 12:25 hrs as the accused persons are liable for prosecution U/S-379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

I therefore pray before you, kindly lodge an FIR against the owner of the Truck WB33C-5775 and arrested accused driver (1) Abdul Rahaman SK (26 yrs) S/o-Balu SK of Vill-Pakhanna PS-Borjora Dist-Bankura (2) Arif Bhangi (21 yrs) S/o-Sariph Ali Bhangi of Vill-Methiadahar PS-Gorbetha Dist-Paschim Medinipur Helper as per law and arrange for its investigation.
