I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Baburam Hansda, S/O-Lakhan Hansda of Vill- Dambera, P.S- Joypur, Dist- Purulia has committed theft of electricity U/S 135(1) (b) of electricity act 2003 subsequently amendment act 2007.

On 26.07.2023 at about 01.50 P.M I, Sri Rabindranath Das, AE & Station Manager, Joypur CCC along with 01. Raushan Kumar, JE(E) Gr-II, Joypur CCC, 02. Shibaram Mahato, Gr-I TSH, Joypur CCC entered the premises of Baburam Hansda, S/O-Lakhan Hansda of Vill- Dambera, P.S- Joypur, Dist- Purulia and found that Baburam Hansda, S/O-Lakhan Hansda was enjoying electricity unauthorizedly from the incoming service line of WBSSEDCL by meter bypassing by connecting outgoing wire with incoming wire to his domestic premises and connected load found 0.33 KW. As that Baburam Hansda, S/O-Lakhan Hansda committed theft of electric power. No article has been seized. Only connection has been disconnected from the circuit. The inspection team left the premises at 02.10 P.M.

Baburam Hansda, S/O-Lakhan Hansda of Vill- Dambera, P.S- Joypur, Dist- Purulia has committed an offence U/S 135(i) (b) Electricity Act, 2003 (Amendment Act, 2007), so you are requested to take cognizance of this complaint and treat it as F.I.R.
