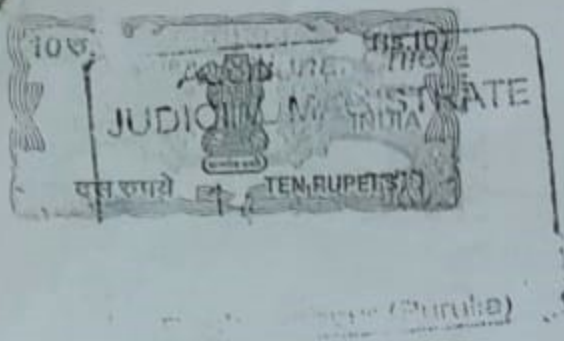

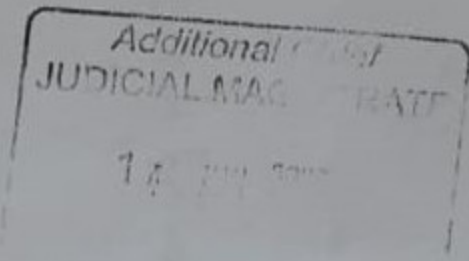

That a vehicle (tractor) having registration no.- WB-41-F-2534 and Trolley having registration mark WB39/TCA/21/2011, chasis no.- 0323/MTW/2011, in the name of PAWAN KUMAR SHAI who is the father of the present complainant and the complainant manage the said vehicle on behalf of his father, with his consent.
3. That on 28/01/2023, the complainant had given the said vehicle to RAJESH GORAI S/O. MAJHI GORAI, resident of Namopara, Kashipur, P.S.- Kashipur, Distt.- Purulia, W.B. on verbal monthly lease of Rs. 11,000/- (eleven thousand only) per month, for the period of 05 years, and for that he advanced the complainant Rs. 50000/- (fifty thousand only) in his A/C. having no.- 35180226261 on 31/01/2023 Rs. 20000/- vide UPI/CR/303103307541/RAJESH/SBIN/897221098927162097 and Rs. 30000/- vide UPI/CR/303187548883/RAJESH/SBIN/897221898955162099, where his driver namely BIJAY BOURI S/O. CHINTA BOURI, resident of

That later on the complainant came to know that said Rajesh Gorai has been arrested in connection with Kashipur P.S. case no- 29/23, dated 19/02/2023, under section 467 /468 471 /420 /406 /120B /34 I.P.C., adding section 411 IPC corresponding to G.R.no.- 110/23 pending before Id. A.C.J.M., Raghunathpur, regarding misappropriation of tractor and trolley of other owners.
5. That the complainant had went to Kashipur P.S. as well as Adra P.S. to lodge the written complaint against said RAJESH GORAI, as he has misappropriate the above noted tractor & trolley, after taking him in faith.
6. That from the above facts stated above, it is transpire that complainant is sustaining great loss and injuri.

Court may deem fit and proper for the ends of Justice, And for this act of kindness the complainant shall ever prays.
