Sub – Prayer for lodging FIR


Respected Sir,

In producing herewith arrested accused person Debnath Paul (42 Years), S/O- Lt Karali Paul of village – Kashipur Chalk bazaar, PS - Kashipur, Dist - Purulia along with seized articles, I beg to report that on 21.07.2023 at 18.15 hrs during my evening mobile duty received telephonic information that the above noted accd. selling liquor near Kashipur Traffic More in his shop. Accordingly I, ASI Satyajit Acharyya along with C/689 Pravash Ch Mahato & C/726 Dipankar Mahato reached near Kashipur Traffic More in the shop of the above noted accused at 18.35 hrs and found that one person was selling Liquor in his house. After seeing police party liquor customers fled away from the spot. On demand the seller failed to produce any valid document for selling liquor in his possession. So the above noted accused has committed an offence u/s - 46(A)(c) B.E. Act 1909 Amended up-to date. During search I found (1) 28 (Twenty Eight) Bottles CS liquor 300 ML each brand as "Dil Khush" 300 ML each out of this 28 (Twenty Eight) 01 bottle took as sample with sealed and labeled. I also seized and labeled all the seized articles under proper seizure list at the spot in presence of accused person and witnesses. Accordingly I arrested the above noted accused person at 19.15 hrs u/s - 67 Bengal Excise Act 1909 and informing her the ground of arrest and I prepared arrest memo after maintaining all arresting rule as well as I brought him to P.S. with above noted seized articles.

Therefore I pray before you that kindly arrange to start a specific case u/s 46(A)(c) B.E. Act 1909 against arrested accused person Debnath Paul (42 Years), S/O- Lt Karali Paul of village – Kashipur Chalk bazaar, PS - Kashipur, Dist - Purulia and arrange for its investigation.
