

Sub: - To lodge FIR against owner and driver of MASSEY FARGUSON 1035 DI (Red & Ash Colour) having Rag. No-WB 56 T 7416 with trolley (without number) sand loaded approx (100 cft).

Sir,

In producing herewith one Tractor MASSEY FARGUSON 1035 DI (Red & Ash Colour) having Rag. No- WB 56 T 7416 with trolley (without number) sand loaded approx (100 cft). of the engine No-S334 15660, Chassis No-MEA 11FA1BM2349844, Model-MF 1035 DI. Myself A.S.I. Anirban Banerje e along with C/1544 Prasenjit Bhattacharya and NVF 697 Debendranath Bauri Vide Manbazer P.S C.C No 1674/23 and GDE No- 738 dt- 20.07.2023 was engaged for night mobile duty. Then on 21.07.23 at 03:05 hrs during my mobile duty received a credible source information that the above noted vehicle (Tractor) is lifting sand illegally at 'Chaka River' bed at village- Keshargaria under PS- Manbazar, Near Kenda PS boarder area, Dist- Purulia. Subsequently myself along with force moved to the spot. We kept our vehicle concealed and moved towards the river bed on foot. Seeing the police party, those persons who were loading sand, fled away from the spot leaving the sand loaded tractor. We rushed and detained the said tractor. We searched the said tractor (Reg. No WB 56 T 7416) and found that the tractor is loaded with sand and also searched surrounding but could not trace out the owner and driver or any other. Hence seized the above noted tractor MASSEY FARGUSON 1035 DI (Red & Ash Colour) having Rag. No- WB 56 T 7416 with trolley (without number) sand loaded approx (100 cft). There is every reason to believe that the driver and owner of the above-mentioned Tractor with ill motive are transporting & lifting sand illegally without any valid document in support of carrying / lifting sand.

Hence, I seized the said tractor with its trolley loaded with sand and brought to Manbazar PS for legal action.

Therefore, I pray before you that a case may kindly be started against the driver and owner of the above-mentioned Tractor.
