Sub: Complain to start a specific case.

Sir,

In producing herewith one arrested accused person namely Jagannath Maji (34 years) S/O- Santosh Maji of Vill-Balitora, PS-Santuri, Dist-Purulia along with one seized scooter (Vespa) without registration number, Engine number and Chassis number not legible and loaded with 500 Kg (Approx) steam coal and approx 07 MT steam coal seized at Dhangajore, PS-Neturia, Dist-Purulia in hidden condition in bushy area, I do hereby lodge a complaint to the effect that on 24.07.23, I, SI Sk. Rahaman along with C/174 Tapan Das Bauri, C/753 Shyam Sundar Mahato and C/1550 Bharat Ghosh all are of Neturia PS were engaged in PS area evening mobile duty vide Neturia PS GDE No- 1015 Dt. 24.07.2023 & CC No- 2315/23 Dt. 24.07.23. In course of PS area evening mobile duty at about 17:15 hrs received secret source information of stocking of huge quantity of steam coal at Dhangajore, PS-Neturia, Dist-Purulia. Accordingly I informed the matter to you and as per your kind order myself along with force left for Dhangajore to work out the information. After reaching there at about 17:35 hrs and after search at the bushy area at Dhangajore and found huge quantity of steam coal was stocked there in hidden condition and found above noted accused person namely Jagannath Maji (34 years) S/O- Santosh Maji of Vill-Balitora, PS-Santuri, Dist-Purulia was trying to escape by riding one scooter without number plate loaded with steam coal, we managed to stop him. He has been asked to produce any valid document in support of stock steam coal and scooter, but he failed to produce any valid documents. Accordingly, I seized the scooter (Vespa) without registration number, Engine number and Chassis number not legible loaded with steam coal weighing approx 500 Kg and out of it 03 Kg as sample and another steam coal weighing approx 07 MT found at Dhangajore stocking place out of it 05 kg as sample under proper seizure list duly signed by available witnesses.

Accordingly, I arrested him after maintaining all arrest rule and on interrogation he disclosed the name of his accomplices as (1) Mithlesh @ Mithua Shaw @ Kuir S/O- Bijoy Shaw @ Kuir (2) Goutam Kuir S/O- Golua Kuir both are of Vill-Hirakhun Kuiripara (3) Kishan Bauri S/O- Lt. Madhu Bauri (4) Tilak Bauri S/O- Lt. Sufal Bauri both are of Vill- Bhamuria Bauripara and (5) Aditya @ Guja Gorai S/O- Lt. Delu Gorai of Vill- Bhamuria Baidyapara all under PS-Neturia, Dist-Purulia & others who were engaged in procuring illegal coal from illegal coal pit and transporting the same in a clandestine manner to another district/state. Necessary arrangement has been made for shifting approx 07 MT seized steam coal and brought the seized scooter with loaded coal at Neturia PS.

So, it is reasonable to believe that the arrested accused Jagannath Maji (34 years) S/O- Santosh Maji of Vill-Balitora, PS-Santuri, Dist-Purulia and above noted his accomplices & others had obtained the said coal either by theft or by any fraudulent means from the illegal coal pits and trying to dispose the same coal in a clandestine manner to another district/state knowing it to be stolen.

Therefore, I pray that a specific case may kindly be registered against accused Jagannath Maji (34 years) S/O- Santosh Maji of Vill-Balitora, PS-Santuri, Dist-Purulia (2) Mithlesh @ Mithua Shaw @ Kuir S/O- Bijoy Shaw @ Kuir (3) Goutam Kuir S/O- Golua Kuir both are of Vill-Hirakhun Kuiripara (4) Kishan Bauri S/O- Lt. Madhu Bauri (5) Tilak Bauri S/O- Lt. Sufal Bauri both are of Vill- Bhamuria Bauripara and (6) Aditya @ Guja Gorai S/O- Lt. Delu Gorai of Vill-Bhamuria Baidyapara all under PS-Neturia, Dist-Purulia & others under proper section of law.
