



The complainant most respectfully sheweth:-

1. That last 14-06-2023 like otherdays, the complainant usually go to his grocerssary shop at Anara Bazar leaving his parents at his residence.

- 2. That at the very day the accused persons in furtherence of common intention illegally entered to the petitioner's house and started using filthy language to the parents of the petitioner/complainant and the accused persons demanded to get back the ornaments of their daughter. And in response the parents of the complainant told your daughter took back entire ornaments along with her when she left.
- 3. That hearing all the accused persons snatched the key of the almirah by threatening and thereafter opening the almirah, the accused persons, forcibly took an amount of Rs:-20/25 thousand
- 4. That at the same time when the parents of the complainant protested not to take said amount from the almirah the accede persons assaulted cruelly the complainant's father/mother etc.
- 5. That thereafter mother of the complainant immediately called over phone to the complainant telling the fact and instantly coming back to his house and rescued his parents from the accedences.
- 6. That at the very time, the accd. persons blow fist and the complianant and before leaving the acced. persons from the place of occurrance warned and intimated the complainant to come again and abduct you.



7. That the complainant went to the Para P.S. on 14-06-23 to lodge the written complaint where the concern Police officer informed the complainant to take shelter of the court.

8. That finding noother alteration the complainant have to take shelter before the Ld. court for the redressal of his grievances
