Sir,

With due respect and humble submission I beg to state that I, S.I Kazi Kawsar Nafis of Para P.S do hereby lodged complaint as suo-motto against arrested accused person namely Manoj Das (30 Yrs) S/o Maheswar Das of Vill- Para Patibaid, PS- Para, Dist- Purulia and 10/12 others who were of same village to the effect that during my R.T. Mobile duty in c/w Panchayet General Election- 2023 vide Para PS GDE No- 292 Dtd- 07.07.2023 & C.C. No- 01/23 Dtd- 07.07.23, got information that some persons were creating nuisance at the premises of Para Girls High School, Booth No- 245/214. I informed O/C Para PS and as per his direction left to Para Girls High School, Booth No- 245/214 with C/1474 Tushar Kanti Mandal and C/3407 Dipak Gorai & NVF/869 Swarup Addy from Para PS who were deployed as P.S. Reserve force. I along with force reached at Para Girls High School at about 15.15 hrs. and found that Manoj Das (30 Yrs) S/o Maheswar Das and 10/12 others all of Vill- Para Patibaid, PS- Para, Dist- Purulia equipped with lathi trying to enter into the Polling Station by disrupting on duty LC/1237 Runa Mondal who was deployed for booth duty in c/w Panchayet General Election- 2023. They also threatened the said on duty LC/1237 Runa Mondal. Accordingly I tried to intervene into the matter for neutralizing the situation but they did not pay any heed. Moreover, get on us and assaulted C/1474 Tushar Kanti Mandal, C/3407 Dipak Gorai & NVF/869 Swarup Addy with their equipped with lathi and also torn the uniform of C/3407 Dipak Gorai. As a result they received injuries on their persons and treated at Para BPHC. Finding no other alternative way, I arrested the above noted accd. person after observing all formalities regarding his arrest and others fled away from the premises of Para Girls High School, taking advantage of our under strength.

As such, they deter the Police team from performing the Govt. Duty and voluntarily attempted to interfere with the free exercise of electoral right using undue influence. Under the facts & circumstances, I pray to lodge a FIR with proper sections in under to prosecute the above noted arrested & other 10/12 persons.
