Sub: Complaint for starting a specific case.

In producing herewith one arrested accd. namely Lalan Bauri (25) S/O Late Satish Bauri of vill- Gurtupa, PO- Pedda, PS_Manbazar Dist- Purulia driver of Truck bearing Reg No- WB55A-6756 said track loaded with Scrap Iron approx.8.5 ton along with said Truck under proper seizure list. I beg to submit that today (18/07/2023) I, ASI Sanjib Kr. Patra along with C/1548 Subrata Paramanik & C/752 Durjadhan Sing Sardar both of Puncha PS were performing anticrime evening mobile duty at PS area vide Puncha PS CC No -1768/23 Dt- 18/07/2023 and at about 16:35 hrs, I received credible source information that one Truck coming from Manbazar side towards Lalpur side under Puncha PS loaded with Scarp Iron. Accordingly I intimated the matter to you over phone and as per your direction we rushed to the Dhadki more under Puncha PS and started Naka checking to work out the information and at about 16:55 hrs we found that above noted Track was coming from Manbazar Side towards Lalpur on Manbazar Lalpur road but on seeing the police party the driver of above noted Truck suddenly stopped approx. 30/50 meter away from us, driver got down from the Truck and started running. We chased to apprehend him and finally was able to apprehend him. Then we searched the Truck and found that the vehicle (Truck) having registration No- WB55A-6756, loaded with iron Scrap (approx.) 8.5 ton. On interrogation the driver of the said Truck confessed his guilt and he disclosed his identity as Lalan Bauri (25) S/O Late Satish Bauri of vill- Gurtupa, PO- Pedda PS_Manbazar Dist- Purulia and he also confessed that Registered owner of the said scrap loaded Truck and one Budheswar Gorai s/o Late Ganesh Gorai of Charki, PS-Manbazar, Dist-Purulia asked him to drive the said Scrap Iron loaded truck and they almost were passing this type scrap by vehicle. On demand he failed to produce any valid documents in respect of above noted Truck along with loaded Scrap Iron as well as D/L of the accd driver.

So, there is reason to believe that the driver, and registered owner of this scrap iron loaded vehicle (Truck) as well as one Budheswar Gorai s/o Late Ganesh Gorai of Vill-Charki, PS-Manbazar, Dist-Purulia & others collected the said Scrap Iron from anywhere either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same at anywhere in a clandestine manner knowing it to be stolen as per their regular practice.

Accordingly I seized the said Truck bearing Registration No-WB55A-6756 along with loaded approx.8.5 ton Scrap Iron under proper seizure list duly signed by him and other witnesses and arrested him in c/w this case. So the driver, & Register owner of the said loaded scrap Iron Truck as well as involved one Budheswar Gorai s/o Late Ganesh Gorai of Charki, PS-Manbazar, Dist-Purulia have committed offence u/s- 379/411/413/414/120B IPC.

Under the above fact and circumstances a specific case may kindly be started against the driver and the registered owner of the vehicle (truck) bearing Reg. No.- WB55A/6756 and one Budheswar Gorai s/o Late Ganesh Gorai of Charki, PS-Manbazar, Dist-Purulia, under proper section of law and arrange for its investigation.
