Respected Sir,

In producing herewith the arrested drivers namely (i) Subhajit Mahato (22Yrs) S/o- Bimal Mahato (ii) Ramesh Sing Sardar (24 Yrs) S/o- Netai Sing Sardar (iii) Sagar Mahato (21Yrs) S/o-Tarapada Mahato all of Vill- Anai, PS- Purulia (M), Dist- Purulia along with seized 03 vehicles (Tractor) bearing Reg. No. (i) WB 55B 1865 (ii) WB 55B 3672 & (iii) WB 55B 5761 attached with 03 (three) sand loaded trolleys and Seizure list, Arrest Memos in respect of the above noted persons.

The fact brief is that today (30.06.2023) at 06:45 hrs while I along with force(i) C/- 988 Maheswar Kora &(ii) C/- 2734 Susanta Panda both of Purulia (M) PS, Dist- Purulia left the PS for Spl. mobile duty vide Purulia (M) PS C.C No-2844/2023 Dtd. 30.06.2023 and GDE No- 1522 Dtd.30.06.2023 in PS area. During my Spl. mobile duty, I received a tip off at 11:25 hrs that three suspicious tractors loaded with sand were coming from the Kansai river side towards Amjora village. Subsequently, I along with force proceeded towards Amjora morh to work out the information. While I, along with the force, arrived at Amjora morh and found that 03 (three) tractors were proceeding towards Amjora village. I along with force intercepted the vehicles (Tractor) bearing No- (i) WB 55B 1865 (ii) WB 55B 3672 & (iii) WB 55B 5761 attached with 03 (three) sand loaded trolley loaded with Sand at 12:05 hrs and I found the vehicles as well as goods identical as I received prior information. On being asked, the drivers of said vehicles disclosed their name and identity noted above. I asked the drivers of the vehicles to produce the valid documents in respect of the vehicles as well as the loaded sand. But the drivers of the said vehicles were not able to produce any kind of documents in respect of the Tractors and loaded sand. I repeatedly asked the drivers to produce the valid papers but they stated differently at different times. The incoherent statement of the drivers purported to be suspicious to us. It was ascertained that the drivers of the tractor loaded the said sand in cahoots with the owners of the vehicles by illegal means for selling the same to make profit by dishonestly and they have been running a clandestine business. So it is reasoned to belief that he in cahoots with the owners of the vehicles procured the said sand form Kansai River near Anai Ghat under Purulia (M) PS side by fraudulently means or theft by any means for transporting the same to run clandestine business. So I seized the vehicles (tractor) bearing No-(i) WB 55B 1865 (ii) WB 55B 3672 & (iii) WB 55B 5761 attached with 03 (three) Trolleys loaded with Sand Approx 100 c.f.t. under proper seizure list in presence of available witnesses duly signed by them and also arrested the drivers namely (i) Subhajit Mahato (22Yrs) S/o- Bimal Mahato (ii) Ramesh Sing Sardar (24 Yrs) S/o- Netai Sing Sardar (iii) Sagar Mahato (21 Yrs) S/o-Tarapada Mahato all of Vill- Anai, PS- Purulia (M), Dist- Purulia after informing the ground of arrest after issuing Memo of Arrest. Thereafter, I brought the seized tractor to Purulia (M) PS compound for safe custody.

Under the above facts and circumstances may kindly take lawful action against the owners of seized Tractors bearing No- (i) WB 55B 1865 (ii) WB 55B 3672 & (iii) WB 55B 5761 attached with 03 (three) Trolleysand drivers of said Tractors namely (i) Subhajit Mahato (22Yrs) S/o- Bimal Mahato (ii) Ramesh Sing Sardar (24 Yrs) S/o- Netai Sing Sardar (iii) Sagar Mahato (21Yrs) S/o- Tarapada Mahato all of Vill-Anai, PS- Purulia (M), Dist- Purulia under proper section of law.
