Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused driver namely Sudarshan Mudi (21 Yrs) S/o- Suchand Mudi of Vill+PO- Kudlung, PS- Hura, Dist- Purulia along with seized Tractor bearing Reg. No- WB 55B 1923, attached with trolley loaded with sand approx 100 cft, Seizure list, Memo of Arrest before you.

The nub of the fact in a nutshell is that on 19.07.2023 while I, SI Paromita Samaddar along with force (i) C/- 699 Biswajit Banerjee & (ii) C/- 1410 Saroj Kr. Patra of Purulia (M) PS left the PS for performing special mobile duty vide Purulia (M) PS GDE No- 1224 Dtd. 19.07.2023 in PS area. During my special mobile duty, I received a tip off at 19.25 hrs that 01 (one) suspicious tractor loaded with sand was coming from Anai Jambad village towards Hutmura village. Subsequently, I along with force proceeded towards Hutmura village to work out the tip off. While I along with the force arrived at Hutmura, near Kabarsthan under Purulia (M) PS, we found that 01 (one) tractor was proceeding towards Hutmura Basti area by village road. I along with the force intercepted 01 vehicles (Tractor) having Reg. No- WB 55B 1923 attached with Trolley is loaded with sand at 19.55 hrs and I found that the vehicle as well as goods were identical as I received prior information. On being asked, the driver of the Tractor disclosed his name as Sudarshan Mudi (21 Yrs) S/o- Suchand Mudi of Vill+PO- Kudlung, PS- Hura, Dist- Purulia. I asked the driver of the Tractor to produce the valid documents in respect of the Tractor as well as the loaded sand. But the driver of the said Tractor was not able to produce any kind of documents in respect of Tractor and the sand. I repeatedly asked the driver to produce the valid paper but he stated differently at different times. The incoherent statement of the driver purported to be suspicious to us. It was ascertained that the driver of the tractor loaded the said sand in cahoots with the owner of the Tractor by illegal means for selling the same to make their own profit by dishonestly and they had been running a clandestine business. So it is reasoned to believe that the alleged driver in cahoots with the owner of the Tractor procured the said sand form Kansai River near Anai Jambad village side by fraudulently or theft by any means for transporting the same to run clandestine business. So I seized the Tractor having Reg. No- WB 55B 1923 attached with Trolley, loaded with sand approx 100 cft under proper seizure list in presence of available witnesses duly signed by them. The seizure was done in between 20.05 to 20.15 hrs. Also arrested the alleged driver namely Sudarshan Mudi (21 Yrs) S/o- Suchand Mudi of Vill+PO- Kudlung, PS- Hura, Dist- Purulia after informing the ground of his arrest and issued Memo of Arrest against him. The arrest was made at 20.15 hrs. Thereafter, I brought the seized tractor and alleged arrested driver to Purulia (M) PS.

Under the above facts and circumstances, I therefore, pray you kindly take lawful action against the owner of seized Tractor having Reg. No- WB 55B 1923 and the arrested driver namely Sudarshan Mudi (21 Yrs) S/o- Suchand Mudi of Vill+PO- Kudlung, PS- Hura, Dist- Purulia under proper section of Law.
