





seeing no other alternative the petitioner posted the same through registered post on 01.07.2023 and after receiving the complain no action has been taken by the officials of Sadar Women P.S.

14. That subsequently, the Complainant on 07.07.2022 informed the matter to the Superintendent of Police, Purulia but even then as no step has been taken against the Accused Persons by the police, the Complainant is being compelled to lodged this Petition u/s 156 (3) Cr.P.C. before Your Honour's Court.

It is therefore prayed that your Honour will be graciously pleased to send this petition to Officer-in-charge of Purulia (Sadar) Women P.S. to treat this petition as an FIR as contemplated u/s 156(3) Cr. P.C. and to investigate the case in accordance with law and to unearth the wrongdoer

provide such sum, the petitioner was badly assaulted on 18.06.2023 and thereafter as the physical condition of the petitioner was very bad, she requested them for consult with a doctor, but they neither bring the petitioner for treatment nor provided any medicines.

- 11. That seeing all such incident said Arzu somehow managed for the mobile of the mother-in-law of the petitioner and help the petitioner to call her parents and the petitioner reported the incident to her brother. Hearing this the brother of the petitioner along with his friend somehow managing tickets reached Chennai by flight on 22.06.2023, and unfortunately the in-laws of the petitioner heard the conversation of the petitioner with her brother as recording of conversations was open in the mobile phone and after hearing such recording, the petitioner was brutally assaulted by all in-laws of the petitioner by use of Lathi, iron rod, sleepers, fist, blows by caught hold of her hair and they also pressed the neck of the petitioner with an intention to kill the petitioner. By this time when the brother of the petitioner make call in the mobile of the accused No. 1, he immediately bring the petitioner to a nearest place from the house where the brothers of the petitioner were waiting by an auto along with the articles and after handing over the petitioner the accused No. 1 fled away and his mobile was found switch off.
 - 12. That the brother of the petitioner tried his level best to contact with the accused and his other family members and also tried to reported the matter to nearest police station, but could not succeed. Seeing no alternative, the petitioner was bring to Purulia on 24.06.2023 and as the petitioner was ill for mercilessly beaten by the accused persons and his other family members and they attempt to kill the petitioner by pressing her neck the petitioner had to admitted in Deben Mahato Medical College and Hospital, Purulia on 25.06.2023 and after discharge.
 - 13. That after release from the hospital, the petitioner had been to the Purulia Sadar Women P.S in order to lodge a complaint, but the officers of P.S refused to accept the same as the complaint was written in English and directed the petitioner to write in Bengali. Thereafter on the next day i.e on 26.06.2023 the petitioner again went to lodge complaint in Bengali, but the officers also directed the petitioner to delete some material portions of the complaint and








as they used to eat and when the petitioner expressed that as per direction of the doctor, she is providing such diet, he used to assault the petitioner mercilessly.

- 8. That the accused persons always used to direct the petitioner to closed the windows throughout the day and night, the petitioner never allowed to go outside from the house, never permitted to talk with others even certain restrictions were imposed for talking with her parents over telephone.
- 9. That thereafter, suddenly the husband of the petitioner demanded a sum of Rs. 5,00,000/- for purchasing a land and hearing such fact the elder brother of the petitioner approached for gifted away a plot of land to the petitioner and firstly the accused No. 1 agreed to the proposal and bring the petitioner to Purulia and started to reside in the parents' house of the petitioner, but after some days he asked the brother of the petitioner to sell out the plot and handed over the sale proceed in his hand and on refusal he badly assaulted the petitioner, abused her entire family members in filthy languages and fled away. Since then, the petitioner along with her child used to reside at her parents' house and inspite of the best effort by the petitioner, she could not be able to contact with the accused No.1.
- 10. That on 24.05.2023 suddenly the accused No. 1 came to Purulia and bring back the petitioner to Dhanbad and on the very next day i.e on 25.05.2023 he also bring the petitioner to Chennai along with his brother namely Saiyad Md. Habib, his mother namely Mariyam Bibi and the daughter of the sister of aacused No.1 namely Arzu. After reaching Chennai the petitioner saw that her elder brotherin-law namely Saiyad Md. Naseeb was there and it has come to learn to the petitioner that her husband and his elder brother, both used to work as a JCB operator and used to reside there in a rented accommodation. During stay at Chennai the same things were repeated. Firstly the in-laws snatched the mobile of the petitioner and broke it. The petitioner and her child were not provided with proper foods and day to day necessities, The petitioner was not allowed to go outside, always scold for not opening the windows of any room, accordingly the petitioner used to pass each and every day under constraint pressure that she will be beaten at any time in the hands of her in-laws. The petitioner was again asked for the said money of Rs. 5,00,000/- for purchasing of a land and disclosing the fact that the father or brother of the petitioner have no means to









inferior quality and thereafter the mother-in-law of the petitioner took all those ornaments in her custody. After few days of the marriage, the accused No. 1 demanded Rupees two Lakh as additional dowry and whenever the petitioner expressed the inability of her father to fulfil their such additional dowry demand, she faced inhuman torture by her husband, even she was not provided with adequate food, care, medical treatment, the articles of her day-to-day necessity such as soap, oil etc.

- 4. That after couple of months from the marriage the husband of the petitioner went to Raipur and started a job of JCB operator and in absence of him, the petitioner was subjected to various means of torture in the hands of her in-laws and her husband supported them over telephone. Subsequently, the petitioner conceived but hearing such news the husband of the petitioner instructed his other family members to send the petitioner to her parents' house on the pretext that they will not bear the expenses of delivery, accordingly the petitioner was compelled to go to her parents' house in the month of March, 2021 and she have given birth of a male child namely Saiyad Md. Hashnat on 29.07.2021 and due intimation was given to her husband as well as his family members, but nobody came to bless the child.
- 5. That after one and half month from the date of birth of the child the husband of the petitioner came at Purulia and instead of seeing the child started to abuse the petitioner and her other family members by saying that the doctors and medical facilities provided to the child is not good and started to assault the petitioner mercilessly.
- 6. That after three months of delivery of the child i.e in the month of October, 2021, the petitioner at her own instance went to her matrimonial house along with her child and after reaching there she noticed that the behaviour of her husband and in-laws were completely rude, She noticed that she have become the eye sore and they snatched all the baby care articles from the clutch of the petitioner and used to told that the child is not supposed to use such costly articles as they never use those types of articles at their childhood.
- 7. That the accused No. 1 never brings any baby food for the child such as Milk, cerelac, Nan-pro etc., rather used to direct the petitioner to provide normal food




