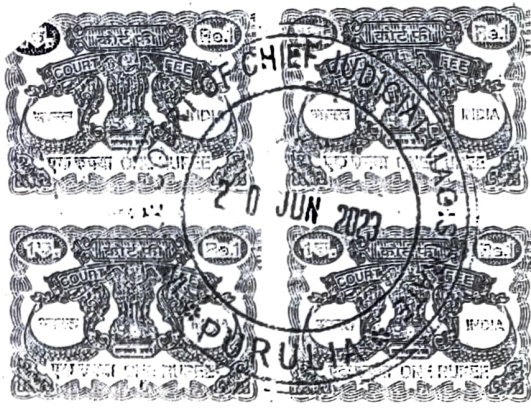

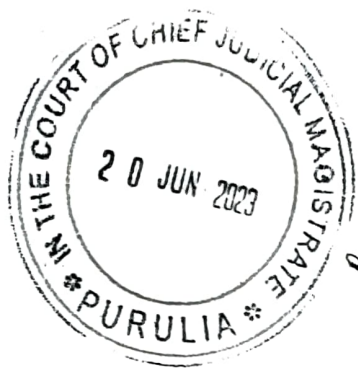

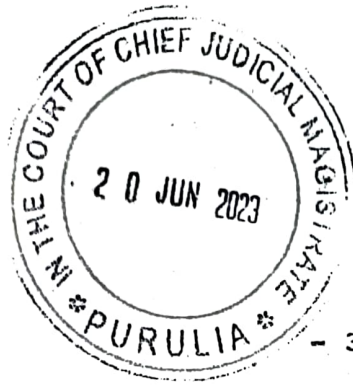
In the matter of a humble petition on

Most respectfully sheweth :-

1) That, the complainant as well as the accused happen to be the residents of the same locality ~~near~~ namely, Reni Road, Sekra Para under the Purulia (T) P.S. within the jurisdiction of this Ld. Court.

2) That, last on 14/03/2023 at about 9 p.m. the complainant was having his night meal inside his house when he heard commotion outside his house and found that the accused persons were standing outside and were hurling filthy comments towards the members/ inmates of the house of the complainant.

3) That, soon ~~at~~ thereafter accused Rakesh Bauri entered into the house of the complainant with a lathi in his hand and caught hold of the tuft of hair of the complainant and dragged him out of the house and the complainant thereafter found that the rest of the accused persons were having lathi,

brick backs, stones in their respective hands.

Accused Rakesh Bauri first of all assaulted the complainant on his head with the lathi in his hand saying that " I would put an end to your life today." The complainant having received bleeding injury on his head fell down on the ground when the rest accused persons started assaulting the complainant with the respective weapons in their hands with a view to killing the complainant.

4) That, the complainant having found no alternative in order to save his life started shouting when the witnesses including the para people rushed to the spot on hearing such hue and cry and on their arrival the accused persons took to their heels.

5) That, the complainant thereafter was taken to Sadar Hospital, Purulia by some of the witnesses and got him admitted there as an indoor patient.

6) That, the complainant even after his discharge from the Hospital was not in a position to follow his ordinary pursuits for a considerable period.

7) That, the complainant, despite his ailing condition lodged written complaint with the Purulia (T) P.S. inter alia narrating the entire incident, on 15/03/2023 but as even after the lapse of a week no case was registered by the P.S. against the accused the complainant sent the complainant to the Inspector-in-charge, Purulia (T) P.S. through registered post last on 23/03/2023 but to no effect. Lastly the complainant informed the matter in writing to the Superintendent of Police, Purulia on 29/03/2023 but till

date no specific case has been registered against the accused persons by the P.S. concerned over the incident depicted hereinabove.

8) That, the fact of the case highly warrants Police investigation.

It is, therefore, prayed that your Honour may graciously be pleased to accept the petition of complainant and may further be pleased to pass an order directing the Inspector-in-charge of Purulia (T) P.S. to cause investigation of the case as envisaged U/s. 156(3) of the Code of Criminal procedure.
