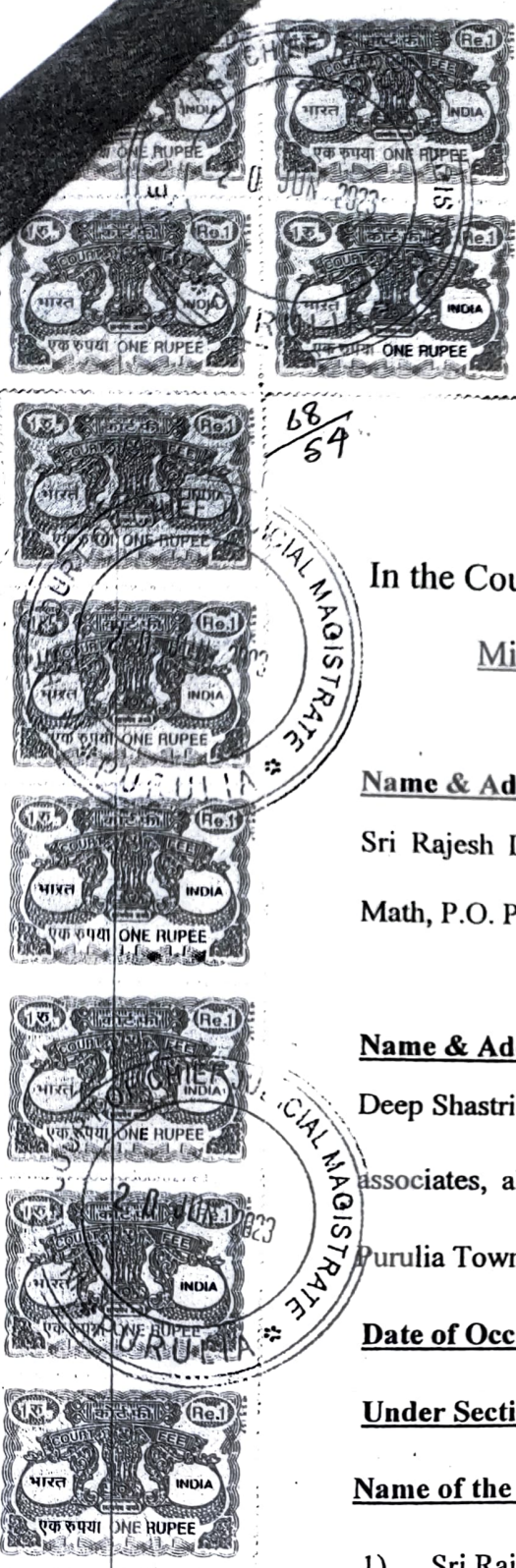

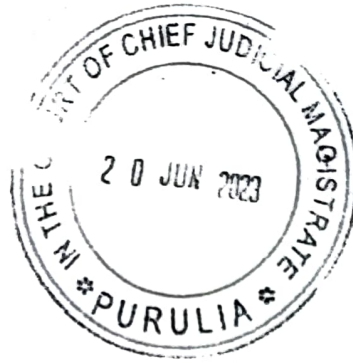

- 1) That the complainant is the permanent resident of Ketika Bhagat Math, P.O. Purulia, P.S. Purulia Town, Dist- Purulia, and the accused persons are the resident of Ketika Sayerpara, P.O. Purulia, P.S. Purulia Town, Dist- Purulia and within the jurisdiction of the Ld. Court.
- 2) That on the date of incident i.e. on 16/05/2023 at 7:30 pm while the complainant himself was passing through Saheb Bandh Road to the eastern side of the Bandh and when the complainant reached near Surya Mandir at that time all the above noted three accused persons out of previous grudge represented the complainant and the accused persons

without any provocation assaulted the complainant mercilessly with the help of some sharp cutting weapon like "Punch" on the forehead of the complainant for such assault the complainant sustain grievous bleeding injury in his person and became senseless.

- 3) That thereafter, the complainant was admitted Purulia Deben Mahato Sadar Hospital for treatment wherein the complainant was treated therein by the concerned doctor and also referred for better management. Accordingly the complainant thereby treated at Bokaro in a Hospital.
- 4) That still now the complainant is undergoing treatment and is feeling very much uneasy for his injury.
- 5) That the accused persons committed various offences punishable under the Indian penal code for which they are deserved to be punished under the law.

- 6) That the matter was reported to the Officer-in-charge Purulia Town P.S. against the accused person but the said Officer-in-charge did not taken any legal action after passage of considerable time then the complainant lodged another complaint to the Superintendent of Police, Purulia but with same fate, then the complainant is under compelling circumstances is filing this complaint before the Ld. Court for appropriate reliefs under the law.

It is therefore, prayed that your honour may be pleased to sent the petition of complaint to the Officer-in-charge Purulia Town P.S. for treating the same as FIR under section 156(3) for investigation .
