Sub-Complain against physical assault of our nursing staff Konika Mahato on 24th July 2023

Respected Sir,
Greeting from Rotary Club of Purulia Service Centre Multi Specialty Hospital

Myself Mr. Sushil Beltharia is designated as HR-Manager in Rotary Club of Purulia Service Centre, Purulia, West Bengal .

I am writing to you with reference to the attached letter because I would like to make a formal complaint on behalf of Rotary Club of Purulia Service Centre Multi Specialty Hospital against Ms Smita Goswami D/O Pankaj Goswami Address- Bibir Bandh Para, P.O-Dulmi Nadiha, Dist-Purulia, 723102. Yesterday on 24th July 2023 morning at around 11.50 am she assaulted one of our nursing staff named Ms. Konika Mahato who was posted in the Annex Male ward (3rd Floor) in morning shift and also was in allocation of Mrs Alpana Goswami, who was admitted in cabin number 14 of our hospital. As normal days she carried out her work as per her role & responsibilities.

At around 11.50 am while she visited cabin no.14 for regular checkup of patient Mrs. Alpana Goswami W/O Pankaj Goswami their daughter Ms Smita Goswami argued with Ms Konika Mahato (our staff) and loudly asking about patient's condition in violent manner and suddenly Ms. Smita Goswami pull down Ms. Konika Mahato and slapped in her left cheek and Physical assaulted in presence of colleagues and security guards.

So I request you kindly take necessary steps on the above said incident. After the incident she has gone under treatment and was referred to ENT specialist.
