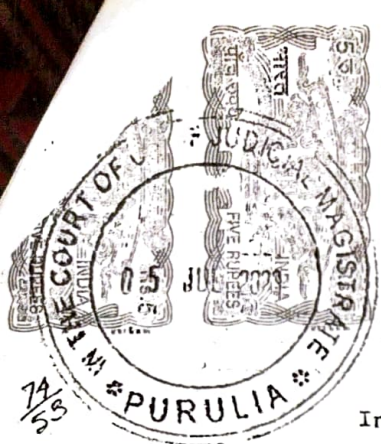

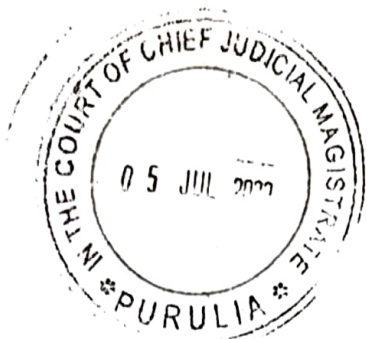

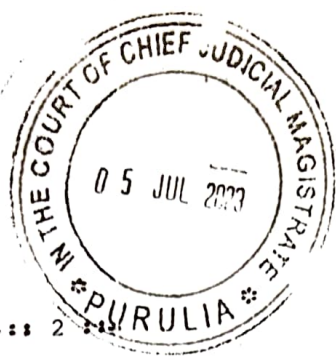

D. Place, Date and Time of Occurrence:-

Occurrence took place at the House of Sk. Jamshed at Chunabhati, Rajabandh, J.K. College Road, Purulia, P.O. P. S. & Dist. Purulia on and from 26-11-2018.

The humble petition on behalf of the above named complainant;

Most respectfully sheweth:-

1.---That the Complainant is the legally married wife of the accused No.1 Sk. Jamshed. Their marriage were solemnized on 15th June 2005 as per Islam rites and customs at vill. Rasuldih, P.O. Gerua, P. S. Balarampur, District Purulia and marriage of the petitioner and accused No.1 is still subsisting.

2.---That the marriage of the complainant with accused No. 1 Den Mohar was fixed of Rs. 11,121/- At the time of marriage father of the Complainant gave a Cash of Rs.81,000/- (Rupees Eighty<sup>one</sup> Thousand), 5 (five) Bharics Golden, 10 (Ten) Bharics Silver ornaments, T.V., Divan, Utensil etc according to the demands of the accused persons No.1 to 4.

3.---That after marriage present Complainant went to her matrimonial house at Purulia with accused persons and lived with accused No.1 Sk. Jamshed as husband and wife. Their marriage wedlock one daughter and two sons were born.

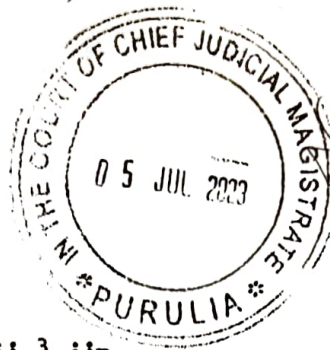
4.---That on and from 26-11-2018 accused persons No 1 to 4 started torture both physically and mentally upon the complainant and asked her bring more dowry from her father's house. When complainant denied to give the same, then accused persons No.1 to 4 created trouble upon the

upon the complainant. She was not given due food and cloths, She was assaulted by the accused persons all along without any occasions. But the complainant bears all such aforesaid trouble very patiently. While the complainant stayed in her matrimonial home. She became ill, but neither any accused persons arranged her medical treatment and they also not providing proper food and clothing as well as medical aid. The complainant informed the aforesaid matter to her father and mother and other relatives. The present accused persons No.1 openly spoke out that he would marry another girl, for further dowry though the father of the complainant had to give Rs.60,000/- (Rupees Sixty thousand) for purchasing Motor cycle.

5. --- That for not giving further dowry to the accused persons, the present accused persons again started beating the complainant at their whims. The accused persons did not provide any food and clothing. The complainant being the devoted wife, requested the accused with folded hands not to assault, illtreat upon her. But they did not pay any heed to the solemn request of the complainant. The accused persons No.1 to 4 did not stop their cruelty and torture upon her. One day present accused persons pulled the hair of the complainant and assaulted her by fists and blows and accused No.1 kicked the right leg of the complainant by his leg for which complainant fell down on the ground. Present complainant sustained bleeding injury on her nose.

6. --- That finally on 15-04-2023, the accused persons No.

No. 1 to 4 assaulted her with fists and blows severally and pressed her make in order to kill the complainant, but some how present complainant saved her life and subsequently present accused persons snatched her all ornaments and drove away the complainant and her daughter from her matrimonial house. Since the complainant and her daughter has been living in the house of her father.

That the incident was reported to the police of purulia (T) Police station. There after to the Superintendent of Polico, Purulia. But the police are quite mum has not started any police case against the accused persons. That the accused persons are very dangerous and desperate type of men. They have illtreated and torture the complainant more over present accused persons No.1 to 4 demanding more and more money from the complainant ~~complainant~~ and as dowry.
