Sub: Prayer for lodging F.I.R. against arrested accused person Bholu Karmakar (65 yrs) S/O- Ghasiram Karmakar of Katin Para, Ward No-22, near Mod Bhati, PS- Purulia (T), Dist. - Purulia.

Sir,

In producing herewith one arrested accused person namely person Bholu Karmakar (65 yrs) S/O- Ghasiram Karmakar of Katin Para, Ward No-22, near Mod Bhati, PS- Purulia (T), Dist. - Purulia under arrest alongwith following seized articles under proper seizure list and being labeled properly:-  
(1) 18 (Eighteen) bottles of Country Spirit designed as 'Dil Khush' (each bottle contains 600 ml of country spirit having strength 80<sup>0</sup> UP and MRP is Rs 55/- being sealed properly) blended and bottled by Purulia Bottling Pvt. Ltd., Vill+ PO Lagda, Dist. Purulia, Pin 723149.  
(2) Out of 18 (Eighteen) bottles 01(one) bottle is kept as sample.

I, PSI Ashoke Mahata, beg to report that while I was performing RT mobile duty vide Purulia (T) PS GDE No 273 dated 05.07.2023, at about 19:45 hrs received a secret telephonic information from source that one person namely Bholu Karmakar (65 yrs) S/O- Ghasiram Karmakar of Katin Para, Ward No-22, near Mod Bhati, PS- Purulia (T), Dist. - Purulia is selling country spirit illegally at a higher price to the customers causing unlawful gain at his dwelling house at Katin Para.

Accordingly I informed the matter to I/C, Purulia (T) PS and after getting his permission myself alongwith my team consisting of C/799 Jagannath Mahato and C/1490 Ganasree Pati all of Purulia (T) PS proceeded to work out the information.

At 20:05 hrs we reached at Katin Para and keeping our Govt. vehicle at a reasonable distance we preceded towards the house of above noted Bholu Karmakar as shown by the source from the distance and found that the said person was selling Country Spirit as noted above to some persons, some persons were found drinking there. Seeing the police, all of them fled away from the spot. On hot chase seller could be nabbed. On interrogation he confessed his guilt as he was selling Country Spirit as noted above to the locals without having any authority at a higher price since long. He also failed to produce any licence in favour of selling, keeping or possessing Country Spirit and the said person disclosed his identity as noted above. On search of the house we found 18 (Eighteen) bottles of Country Spirit designed as 'Dil Khush'(each bottle contains 600 ml of country spirit having strength 80<sup>0</sup> UP) blended and bottled by Purulia Bottling Pvt. Ltd., Vill+ PO Lagda, Dist. Purulia, Pin 723149. As such in between 20:15 hrs to 20:35 hrs I seized the above noted Country Spirit under proper seizure list in presence of witnesses after labeling and seal properly. I also took samples and arrest him at 20:45 hrs observing all the formalities regarding arrest as the said person committed an offence which attracts sec. 46 A (C) of B.E. Act 1909.

Hence, I pray before you to start a specific case against the above noted person under proper section of law and kindly arrange for its investigation.
