Sub: Prayer for lodging F.I.R. against arrested accused person namely Goutam Bauri (32 yrs) S/O-Anil Bauri of Vill.& P.O- Siholi, P.S- Purulia(M), Dist. Purulia.

Sir,

In producing herewith one arrested accused person namely Goutam Bauri (32 yrs) S/O- Anil Bauri of Vill.& P.O Siholi, P.S Purulia(M), Dist. Purulia under arrest alongwith following seized articles under proper seizure list and being labeled properly:-

- (1) 91 (ninety one) packets of 'Dil Khush' each packet contains 32 bottles, 375 ml country sprit having strength 80° (degree) UP for sale in West Bengal only blended & bottled by Purulia Bottling Private Limited, P.O & Vill. Lagda, Pin 723149 and MRP is @ Rs 35/being sealed properly). Total 2912 Bottles.
- (2) 20 (twenty) packets of 'Dil Se' each packet contains 32 bottles, 375 ml country sprit having strength 80° (degree) UP for sale in West Bengal only blended & bottled by Purulia Bottling Private Limited, P.O & Vill. Lagda, Pin 723149 and MRP is @ Rs 35/- being sealed properly). Total 640 Bottles.

Out of which 02 (two) bottle i.e, (one bottle of 'Dil Khush and one bottle of 'Dil Se') are kept as sample.

(3) One blue colour mobile set (Jio) having IMEI NO. 354488202248869/00 and SIM No. 8637360562.

I, ASI Sk. Abdul Jamshed of Purulia (T) P.S, beg to report that at about 14:45 hrs. received a secret information from source that one person namely Goutam Bauri (32 yrs) S/O- Anil Bauri of Vill.& P.O Siholi, P.S- Purulia(M), Dist. Purulia alongwith others transporting country spirit illegally from one abandoned house at Bhagabandhpara under Purulia Municipality ward No. 13 to other places where Panchayet Election-2023 will be held in order to induces to voters to cast vote in favour of him or his selected candidate which causes undue influence at Election. This refers to Purulia (T) PS GDE No 335 dated 06.07.2023.

Accordingly, I informed the matter to I/C, Purulia (T) PS and as per his instruction contacted with O/C Excise, Purulia Sadar Circle and after getting his permission myself along with my team consisting of C/2366 Anupam Das and C/2041 Uttam Man both are of Purulia (T) PS proceeded to work out the information.

At 15:05 hrs we reached at Bhagabandhpara and keeping our Govt. vehicle at a reasonable distance we alongwith O/C, Excise, Purulia Sadar Circle being accompanied with my I/C, Purulia (T) P.S preceded towards the said abandoned house of above noted as shown by the source from the distance and found that the said person is present at there and also found huge quantity of Country Spirit on that place. Seeing the police, all of them fled away from the spot. On hot chase the above noted person could be nabbed. On interrogation he confessed his guilt as he alongwith one Dinanath Bauri S/O Late Sasadhar Bauri of his village are engaging to transport these country sprit bottles to different voters in different boths connivance with one Pradip Mukherjee, Councillors of Purulia Municipality ward No. 13 under Purulia (T) P.S., Dist.Purulia.

He also failed to produce any licence in favour of keeping or possessing Country Spirit and the said person disclosed his identity as noted above. On search of the abandoned house we found (1) 91 (ninety one) packets of 'Dil Khush' each packet contains 32 bottles, 375 ml country sprit having strength 80° (degree) UP for sale in West Bengal only blended & bottled by Purulia Bottling Private Limited, P.O & Vill. Lagda, Pin 723149 and MRP is @ Rs 35/- being sealed properly). Total 2912 Bottles (2) 20 (twenty) packets of 'Dil Khush' each packet contains 32 bottles, 375 ml country sprit having strength 80° (degree) UP for sale in West Bengal only blended & bottled by Purulia Bottling Private Limited, P.O & Vill. Lagda, Pin 723149 and MRP is @ Rs 35/- being sealed properly). Total 640 Bottles and (3) one blue colour mobile set (Jio) having IMEI NO. 354488202248869/00 and SIM No. 8637360562. As such in between 15:35 hrs to 16:15 hrs I seized the above noted articles under proper seizure list in presence of witnesses after labeling and seal properly. I also took samples and arrest him at 16:26 hrs, observing all the formalities regarding arrest as the said person committed an offence after notification of Panchayet Election-2023 by the West Bengal State Election Commission which attracts undue influence at Elections by illegally storing and transporting country sprit to others.

Hence, I pray before you to start a specific case against the above noted person under proper section of law and kindly arrange for its investigation.
