- 1. That the complainant is the permanent inhabitant of Raghunathpur ward no:-13 under Raghunathpur Municipality having his resident on the northern side of the Raghunathpur Chelyama Road wherein the complainant has been residing alongwith his family members since about 40 yrs back.
- 2. That it is to be submitted that the accd. person are the neighbours of the complainant who bear personal gradge and gealousi against the complainant and his in-metes through the accd. persons are were trying to the complainant since. long.
- 3. That being driven by said ill motive the acced. person frequently threw domestic filthy uses and garbages in the houses of the complainant even sometimes threw pices of broken glass on the way of complaint to main road.
- 4. That the complainant raised protest to the above said high handed act of the acced, person but the acced, person bette acced, person picket up the querral.
- person with their common object criminally, tresspass in to the house of the complainant and broken down the boundary the wall of the eastern and northern side of the house premises of the complainant illegally and forcibly and being causing damage to the tue of Rs:-60,000/-(Rupees Sixty thousand only) and while the complainant and his wife raised protest to the above said high handed illegal act of the acced. person xhare then the acced. person became furious abused the complainant and his wife in filthy languages and assaulted the wife of the complainant by lathi on her right hand as a result the wife of the complainant suddenly injury on her right hand.



6. That at the intervention of the witnesses the accd. persons left the house of the complainant given threatening the complt. with dire consequences.

7. That the complainant having no alternative rushed to P.S. at Raghunathpur and lodged complaint before I/C Raghunathpur P.S. but police took no action against the acced. person.

8. That it is to be submitted that the complainant and hid wife have became sufficiently old and have been suffering from various oldaged diseases.

9. That while the police Raghunathpur P.S. took no action the complaint lodge by the complainant before the S.P. Purulia still then no action take by the police against the acced. person till this day hence the complainant has been compelled to came before your for redressal.

In view of the facts and circumstances stated above it is prayed that your Honour may pleased be graciously enough to send this complaint before the I.C. at Raghunathpur for investigation U/S 156(3) treating this complaint as F.I.R. for the ends of justice.
