In producing herewith one seized vehicle (Tractor loaded with sand) having Registration number JH09AP 8198, Engine No.- E3474684 & Chassis No: T053422276KH, attached with Seizure List. The nub of the fact in a nutshell is that today (12.07.2023) while I, along with C/1457 Nityaranjan Rajwar & C/1322 Dilip Kr Baskey, were performing special mobile duty vide Santaldih PS GDE no. 426, dated 12.07.2023, at Santaldih PS area, I, received a tip off at 09:45 hrs on 12.07.2023 that, at Kanki village road, near Kanki Hattola under Santaldih PS, some persons were illegally carrying sand by a suspicious tractor. Subsequently, I along with force proceeded towards Kanki village road, Kanki hattola to work out the tip off. While, I along with force arrived at Kanki village road, Kanki hattola under Santaldih PS and found that, some persons are illegally carrying sand into a tractor.

I, along with force proceeded to detain the vehicle and reached at the spot i.e. Kanki village road, Kanki hattola, PS – Santaldih JH09AP 8198 but seeing the police persons the driver left the tractor having Registration number JH09AP 8198, Engine No.- E3474684 & Chassis No: T053422276KH, loaded with sand and fled away. I tried to find out the name & address of the driver / owner of the tractor but in vain.

During enquiry, it is ascertain that the driver of the said tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business by transporting the same at Jharkhand State. So, it is reason to believe that they in cahoots with the owner of the vehicle procured the said sand by fraudulently means or theft by any means for transporting the same at Jharkhand State to run clandestine business. As per source information, they are habitual offender of this crime, as they have been engaged in the said illegal business since long, behind the eyes of the administration.

So, I, seized the said tractor having registration number JH09AP 8198, Engine No.- E3474684 & Chassis No: T053422276KH, loaded with sand under proper seizure list in presence of available witnesses duly signed by them and brought the seized tractor along with the loaded sand to Santaldih PS.

Under above fact and circumstances, I, pray before you to start a specific case against the Owner & Driver of the above noted tractor having Registration number JH09AP 8198, Engine No.-E3474684 & Chassis No: T053422276KH under proper sections of law.
