Sir.

In producing herewith one arrested accused person named as Hiralal Rajwar (60Y), S/O Lt. Duwari Rajwar of Vill. - Gohria, PS - Santaldih, Dist. - Purulia along with seizure - list and seized items as described below, I beg to state that on 10.07.2023 at about 19.15 hrs I received a source information to the effect that the country spirit has been kept at Paharigora More under this PS in the goomty of above noted accused illegally, with an object to sale. I have informed the matter to I.C. Santaldih PS and this refers to Santaldih PS GDE no. 355, dtd. - 10.07.2023 and as per order of I.C Santaldih P.S. I along with force left for Paharigora more to workout the information with the govt. supplied kit box containing white cloth, sealing wax, seal, papers, carbons, match box, candles etc. I had been to the goomty of Hiralal Rajwar at Paharigora more, P.S. Santaldih at about 19.45 hours. Seeing police party some unknown persons in front of the goomty of Hiralal Rajwar were fled away. However, I could detain one among of them and asked about his identity. He disclosed his name and identity as noted above and as well as admitted that he gathered the country spirit for selling and he was the owner of the said goomty. However, I along with said accused started a search inside the goomty of Hiralal Rajwar and found the following item in the said goomty -

1) 30 (Thirty) bottles 80UP country spirit (Dil khush) each bottles containing 600 ML market value of each being in total approx Rs. 1650/- (One Thousand Six Hundred Fifty only).

01 (one) bottle of 600 ML taken (Dil khush) out of the above as sample packet, labeled and sealed with sealing wax.

2) 05 (Five) bottles 60UP country spirit (Captain) each bottles containing 600 ML market value of each being in total approx Rs. 775/- (Seven Hundred Fifty Five only).

01 (one) bottle of 600 ML taken (Captain) out of the above as sample packet, labeled and sealed with sealing wax..

I interrogated him about the purpose of the stocking and possessing such country spirit. He replied it was the business of him. On repeated question he told that the persons who fled away were his customers (names of those not known to him). However he could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper Seizure List between 20.05 hrs and 20.25 hrs

& took up one bottle of each brand as samples, labeled and sealed accordingly.

Since the allegation against him of possessing, as well as selling the country spirit illegally without any valid papers in his goomty has prima-facie been made out and for the interest of proper investigation, I arrested the above accused at 20.35 hrs accordingly after maintaining all arresting guidelines.

Therefore, I pray before you to start a case under proper section of law against the said accused Hiralal Rajwar (60Y), S/O Lt. Duwari Rajwar of Vill. – Gohria, PS – Santaldih, Dist. - Purulia.
