Sir: Kindly do the needful to lodge First Information Report

Respected Sir,  
I, Dr. Suvadeep Mandal [SUVADEEP MANDAL], S/o. Mr. ASIS K MANDAL  
-L, resident of Durgapur - 713204; currently serving as Medical Officer at  
Muradik BPHC, I was assaulted by the patient party of Mr.  
SK. FIROZ, resident of Vill: MURULIA, on morning of 7/7/23 at  
Muradik BPHC.

Mr. SK. Firoz, a resident of Vill MURULIA, Santuriblock, was  
brought to BPHC (Muradik) with complain of severe pain abdomen, Pt  
was immediately attended and treatment initiated as per clinical  
symptoms. Pt. SK Firoz later developed resp distress, which was  
also attended immediately. But even after all efforts, patient succumbed  
to Cardiac arrest at BPHC. As per protocol CPR was initiated, but  
this was ~~not~~ met with resistance/disagreement by patient attendees  
or patient family. They all teamed up and later assaulted me  
physically at hospital ward. Even after trying to explain that patient  
all efforts are being done to improve patient condition or revive patient.  
They later on took the patient away from hospital. They had verbally  
abused ~~me~~ me as well threatened with further assault later on.

Sir, I request your department to take adequate  
steps to bring the accused to justice and ~~to~~ take adequate steps  
to prevent such things in future. Thanking You —
