Respected Sir,

I, Surajit Kumar Das S/o- Samir Kumar Das of Vill- Kalipur Majhpara, P.O- Karidhya, PS- Suri, Dist- Birbhum, at present posted at Tamna PS, Dist- Purulia as SI of Police producing herewith one arrested accused person namely Sarkar Hembram (58 yrs) S/O- Balai Hembram of Vill- Gosaidih, P.O- Chakaltore, P.S- Tamna, Dist- Purulia with seized articles i.e. 1). One white colour plastic jericin containing approx 19 Ltrs. ID Liquor, 2) 09 pieces plastic glass, 3) One Plastic Bottle containing 1 Ltr. ID liquor as sample which was collected from seized articles SI No-01 which were seized under proper seizure list.

I beg to submit that today (23.07.2023) during my PS area spl. mobile duty acting of a secret source information that one person is selling I.D Liquor in his dwelling home at Gosaidih Village under Tamna PS, so myself along with i) NVF/635 Dhiren Daw & ii) HG/1698 Haradhan Kumar both of Tamna PS came to the spot at about 18:25 hrs and found that one person is selling I.D Liquor to the others. Seeing the Police party, all customers fled way but we managed to apprehend the accused person namely Sarkar Hembram (58 yrs) S/O- Balai Hembram of Vill- Gosaidih, P.O- Chakaltore, P.S- Tamna, Dist- Purulia. On being asked he failed to produce any valid licence /documents in respect of storing and selling of ID liquor. As such I seized 1). One white colour plastic jericin containing approx 19 Ltrs. of ID Liquor, 2) 09 pieces plastic glass, 3) One Plastic Bottle containing 1 Ltr. ID liquor as sample collected from seized articles from SI No-01 which were seized under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in presence of witnesses. I also arranged to inform his family member about his arrest by police.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Sarkar Hembram (58 yrs) S/O- Balai Hembram of Vill- Gosaidih, P.O- Chakaltore, P.S- Tamna, Dist- Purulia as per proper section of law.
