In producing here with one arrested accused namely Dayal Mahanty (26 Yrs) S/O Lt. Manik Mahanty of Vill-Monipur Leprosy Colony, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

1) 15 (Fifteen) bottles DIL KHUSH country spirit, 600 Ml. each Rs/-55 of each bottle out of them one bottle of country spirit taken from Sl. No. 1 duly sealed and labeled as sample.

I SI Uttam Kumar Ray of Adra PS do here by lodged a complaint against accused namely Dayal Mahanty (26 Yrs) S/O Lt. Manik Mahanty of Vill-Monipur Leprosy Colony, PS-Adra, Dist- Purulia to the effect that on 02/08/2023 at about 20:05 hrs I received a telephonic information from a reliable source during my evening mobile duty at P.S area vide Adra PS CC NO-2183/23 dtd.02/08/23 that one Dayal Mahanty has been stock of country spirit illegally at his Jhupri beside the Monipur Primary School. After getting such information I informed to my I/C and as per his direction I along with my accompanied force reached at Monipur Leprosy Colony at about 20:35 hrs and hold raid in the Jhupri of said Dayal Mahanty and found that the said person selling liquor at his Jhupri and after seeing the Police party some person fled away and said Dayal Mahanty has tried to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid License or valid papers for selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Dayal Mahanty selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest. The complete process was done in between 20.45 hrs to 21.25 hrs.

Hence I there for pray that a specific case may kindly be started against arrested accused Dayal Mahanty (26 Yrs) S/O Lt. Manik Mahanty of Vill-Monipur Leprosy Colony, PS-Adra, Dist- Purulia under proper section of law.
