In producing here with the arrested accused persons namely (1) Rupesh Kumar Paswan @ Chattu (27 Yrs), S/O Raju Paswan, (Driver of the vehicle having Reg. No UP64 BT/7259 loaded with approx 35 M.T Coal) (2) Birendar Biswakarma (24 Yrs) S/O Arvind Biswakarma Both of Vill-Purhe, PO-Karui, PS-Manjhion, Dist-Garhwa, (Khalasi of the vehicle having Reg. No UP64 BT/7259) and seized one vehicle having Reg. No-UP64BT/7259 loaded with approx 35 M.T Coal.


The fact of the case in brief is that on 23.08.23 myself along with forces, C/2687 Ramanuj Mahanti, C/2939 Bikash Ch. Guli Majhi and HG/1682 Amal Majhi all of Adra PS were performing special mobile duty in Adra PS area vide Adra PS Spl.CC No 256/23 dtd.23.08.23 at about 11.35 hrs received a credible source information that the above noted truck loaded with coal was coming from Raghunathpur side towards Kashipur side receiving such information I informed the matter to I/C Adra PS and as per his direction we reached at Adra-Kashipur pitch road near Wireless Ground under Adra PS and waiting there. At about 11.55 hrs, we noticed that one Truck was coming from Raghunathpur side we stopped the said truck and on searching it is found the registration no of the truck is UP64 BT/7259 and coal was loaded in the truck. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded coal. But the driver and Khalasi of the said vehicle could not able to produce any kind of documents in respect of the truck and the coal. I repeatedly asked the driver and Khalasi to produce the valid paper but they stated differently in different times. The incoherent statement of the driver and Khalasi purported to be a suspicious them to us. It was ascertained that the driver and Khalasi of the said truck loaded with coal with the owner of the vehicle by illegal means for selling the same to make profit dishonestly and they had been running a clandestine business. As such it is every reason to believe that the driver, Khalasi, owner of the said truck and owner of the said coal were transporting the coal illegally. As such I arrested the accused driver of the above noted truck namely Rupesh Kumar Paswan @ Chattu (27 Yrs), S/O Raju Paswan and Khalasi of the said vehicle (2) Birendar Biswakarma (24 Yrs) S/O Arvind Biswakarma Both of Vill-Purhe, PO-Karui, PS-Manjhion, Dist-Garhwa, after observing all formalities and narrating them the ground of arrest. I also seized the truck having registration No UP64 BT/7259 loaded with coal under proper seizure list in presence of police party duly signed by them.

I therefore pray before you kindly lodge FIR against the arrested accd truck driver of the above noted truck namely Rupesh Kumar Paswan @ Chattu (27 Yrs), S/O Raju Paswan and Khalasi of the said vehicle (2) Birendar Biswakarma (24 Yrs) S/O Arvind Biswakarma Both of Vill-Purhe, PO-Karui, PS-Manjhion, Dist-Garhwa and also owner of the truck Reg. No WB UP64 BT/7259 and owner of the seized coal as per law and arrange for its investigation.
