Prayer for starting a specific case against PC accused Sahadeb Keora (40 Yrs) S/o Jagat Keora of Sub: Vill. - Dubradih, PS- Adra, Dist. - Purulia.

In producing here with the seized articles under proper seizure list (enclosed here with) i.e. (i) Sir. Exhibit Mark-'A'- One white coloured nylon bag (ii) One white colour transparent Jaricane containing red coloured liquid said to be codeine mixture weighing 3020 gm including jaricane (From which two sample of 100 gm each has been taken out. Rest 2820 gm including jaricane is left) marked and labeled as Exhibit-B (iii) 100 gm codeine mixture as test sample which has been taken out from the Exhibit-B, marked and labeled as Exhibit Mark-'C' (iv) 100 gm codeine mixture as security sample which has been taken out from the Exhibit-B, marked and labeled as Exhibit Mark-'D' all exhibit are in properly sealed and labeled condition under proper seizure list.

LSI Muktipada Ghosh of Raghunathpur PS beg to submit that on 27/08/2023 myself along with other PS officers interrogated the PC accused namely Sahadeb Keora (40) S/o Jagat Keora of Vill.-Dubradih, PS - Adra, Dist.- Purulia in e/w Raghunathpur PS Case No. 91/23 dtd 29.06.2023 U/S 380 IPC at Raghunathpur PS. During interrogation he confessed his guilt and stated that he committed the crime with other associates. He also confessed that he is habitual dealer of contraband narcotic drug articles and some contraband narcotic drug articles has also been kept by him in his house at village-Dubradih, PS-Adra, Dist-Purulia for commercial purpose. He also agreed to help the police to recover the said contraband narcotic drug articles from his house. I have recorded his statement u/s 161 Cr. P.C. and at once the information brought to the notice of my immediate superior i.e. IC, Raghunathpur PS and as per his direction myself along with C/716 Achintya Majee and (2) C/102 Somnath Maity accompanied with PC accd Sahadeb Keora (40) S/o Jagat Keora of Vill.- Dubradih, PS - Adra, Dist.- Purulia after preparing inventory list, by Govt. Vehicle attached to Raghunathpur PS, weighing machine, investigation kit box, white paper, gala, white cloth, carbon paper, stamp pad, seal of Raghunathpur PS, envelope etc. vide Raghunathpur PS CC No. 2379/23 Dt. 27.08.2023 & Raghunathpur PS GDE No-1265 dt. 27.08.2023 left for Adra PS.

Reached at Adra PS at 18:45 hrs and I submitted a requisition before I/C Adra PS for rendering police help over holding raid. Accordingly at about 19.05hrs we accompanied with the police personnel of Adra PS along with the PC accd. left for work out the information as per leading statement of the PC accd. Thereafter I/C Adra PS, Shri Partha Pratim Roy, Inspector of Police along with officers and force accompanied us for holding search and seizure. As per leading statement of PC accd Sahadeb Keora (40) S/o Jagat Keora of Vill.- Dubradih, PS - Adra, Dist.- Purulia. I would like to note here that E-Mail Message was also send to SDO, Raghunathpur for deputing executive magistrate to be present at PO during the process of search and seizure.

On 27.08.2023 at 19:55 hrs after arrival at Dubradih village under Adra PS we tried to get disinterested local witnesses but as the PC accd is a dangerous criminal, being frightened none turned up.

I/C, Adra PS being as Gazetted Officer issued notice to the PC aced Sahadeb Keora mentioning that whether he was willing to search the body of Gazetted Officer along with other accompanying officer and force as no executive magistrate have came to the PO. The content of the notice was read over to the accd, person but he denied to do so.

He also issued another notice in writing upon the said person directing him whether he was willing to be searched his persons before any Gazetted Police Officer. The content of the notice was read over to the accd person. He accorded consent.

In presence and under your kind supervision, PC accused Sahadeb Keora showed his house and opened it. Then as per his identification a white colored transparent plastic jaricane having white cap containing red colored liquid which seems as contraband like substance kept in a white colored plastic bag.

After opening the jaricane an aromatic smell was found so there is reasonable ground to believe that the mixture is said to be codeine mixture. On demand PC accd Sahadeh Keora failed to produce any document in respect of storing of Codeine mixture. During interrogation he stated that he is habituated in dealing of such clandestine illegal business of Codeine mixture for commercial purpose for his wrongful gain knowing the same is a punishable offence. Then I weighted the bottle and it results 3020 grams in Electronic Weight machine. On reasonable belief, an offence has been committed in respect of recovered liquid substance believe to be Codeine from which 100 gm was taken as test sample in two bottles and I seized (i) One white coloured nylon bag as Exhibit Mark-'A'- (ii) One white colour transparent Jaricane containing red coloured liquid said to be codeine mixture weighing 3020 gm including jaricane (From which two sample of 100 gm each has been taken out. Rest 2820 gm including jaricane is left) marked and labeled as Exhibit-B (iii) 100 gm codeine mixture as test sample which has been taken out from the Exhibit-B, marked and labeled as Exhibit Mark-'C' (iv) 100 gm codeine mixture as security sample which has been taken out from the Exhibit-B, marked and labeled as Exhibit Mark-D under proper seizure list duly singed by the PC accused namely Sahadeb Keora (40 Yrs) S/o Jagat Keora of Vill. - Dubradih, PS- Adra, Dist. - Purulia and witnesses and labeled the seize articles on the spot. The whole process of search and seizure was done in between 19.55 hrs to 21.25 hrs.

The accd person is liable for prosecution u/s 21 (c)/29 of NDPS Act, 1985 as amended up to date.

In this circumstance I request you to initiate a case against Sahadeb Keora (40) S/o Jagat Keora of Vill.- Dubradih, PS - Adra, Dist.- Purulia u/s 21(c)/29 of NDPS Act, 1985 as amended up to date and arrange for its investigation.
