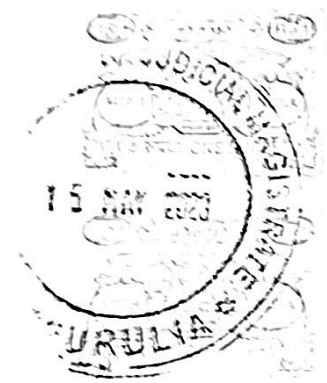

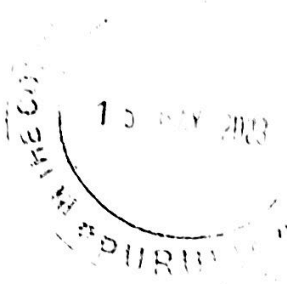

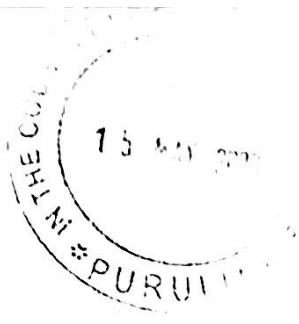
Complainant was compelled to give Rs. 70,000/- (Rupees Seventy thousand) as dowry money to the Accused No.1 and other articles namely golden ear xky rings, one golden Chain with locket, one golden ring, Almirah, dressing table and other utensils to the accused persons.

3) \_\_\_\_\_ That, after marriage both the parties began to reside at Chekia, P.S.- Arsha, i.e. the house of the Accused persons.

4) \_\_\_\_\_ That, since after marriage the husband and his mother Bharati Kumar put pressure upon your Complainant to bring Rs. 1,00,000/- (Rupees One Lakh) more otherwise she would not be allowed to stay there and the mother-in-law separated your complainant from the husband and not allowed to stay her with the husband with the same bed in this way the accused persons <sup>persistently</sup> ~~permanently~~ increased physical as well as mental torture upon your Complainant and the life of your Complainant became very much trouble some and all of them started assaulting her invarious ways with which ~~may~~ she may bring the aforesaid amount and fullfil the further demand of Rs. 1,00,000/- (Rupees One Lakh).

5) \_\_\_\_\_ That, the father of the Complainant requested the Accused persons and expressed his inability to fulfil the demand but of no good.

6) \_\_\_\_\_ That, on 14/04/2023 at about 7 A.M. all the Accused persons assaulted your Complainant by Lathi on her chest, back and the mother in law pushed one pin on her <sup>hip</sup> ~~head~~ opening her saree then your Complainant was compelled to flee away from ~~xxxxx~~ their house in the mean time her father was coming to see his daughter and met her on the way and she was taken to the Begunkoel -dar Hospital for treatment and the Complainant reported the matter to her taking and all other persons.

7) \_\_\_\_\_ That, thereafter your Complainant informed the P.S. though the local P.S. did not take step then the matter was reported to the S.P., Purulia but in vain though the accused persons committed serious offences and tried to take the life of the Complainant.

It is prayed that, your Honour be pleased to send this Petition to the O/C. Arsha P.S., Dist.- Purulia for investigation after treating the same as F.I.R. in U/S. 156(3) Cr.P.C. for the ends of Justice.
