In producing here with one arrested accused person Durga Charan Hansda (30Yrs) S/O Naran Hansda of vill- Harada, P.S.-Arsha Dist-Purulia along with following seized articles.

- 1) One white colour plastic container containing approx 19 ltrs. of ID liquor.
- 2) One 500 ml bottle approx 500 ml ID liquor taken out from of the above container as sample packed with sealing wax and labeled).

1, ASI Janardan Kumar of Arsha PS do hereby lodge a typed complaint against the above noted accused person to the effect that today i.e 12.08.2023 at about 05.35 hrs. during my anti crime night mobile duty near Aharrah morh, under Arsha PS area, received source information over telephone that the above noted accused has been selling ID liquor in his house at Harada village under Arsha G.P. On receiving the source information, I communicated with O/C Arsha PS over telephone and as per his direction I along with C/- 238 Dipak Bagti of Arsha P.S and C/- 796 Indrajit Ghorai of SAP 7th BN camp at Arsha PS, rushed at the house of above noted accused person to work out the information vide Arsha PS C.C. No. 1987/23 dtd-11.08.2023. Reaching at Harada village at about 06.05 hrs. We fixed-up in the house of Durga Charan Hansda (30Yrs) S/O Naran Hansda of vill- Harada, P.S.-Arsha Dist-Purulia and found that selling of ID Liquor was going on there and having seen police all customers managed to escape, but we were able to apprehended the above noted accused person who was selling ID liquor. On demand he failed to produce any valid documents in support of selling ID liquor. So I seized one white colour plastic container containing approx 19 ltrs. of ID liquor under a proper seizure list from his possession in presence of witnesses, properly sealed and labeled it duly signed by the accused person and witnesses out of which approx 500 ml was taken out from the above container as sample packed with sealing wax and labeled it. During interrogation he confessed his guilt. So, I arrested him after observing all the formalities issuing memo of arrest as he was selling ID liquor illegally.

I therefore pray that a specific case may kindly be started against the accused person Durga Charan Hansda (30Yrs) S/O Naran Hansda of vill- Harada, P.S.-Arsha Dist-Purulia under proper section of law.
