

unauthorized use of Electricity by way of bypassing the Energy Meter.

Sr. Sisir Kumar Das, S/O- Banamall Das, A.E & Station Manager of Balarampur CCC of WBSEDCL do hereby lodge complaint against Najimuddin Ansari(User), S/o, Lt. Md Abdul Ansari resides at Khukramura, P.O:- Kantadib, P.S : Arsha, Dist. Purulia to the effect that received an information, that the aforesaid accused person was committing theft of Electricity in his residence by way of tapping the incoming service cable to bypass the proper registration of units in the Energy Meter of WBSEDCL.

Acting upon such Information on 17.08.2023 from 12.54 PM to 1.15 PM I, along with Biswanath Baru (A.E. (S&LP)), Sri Promod Ranjan Barman (S.O.), Sri Shankar Chandra Mahato (A.C.M.), Sri Dayamay Mahato (Sr. T.S.H.), Purulia Region, Sri Manab Kr. Majhi, J.E. Gr-II, Balarampur CCC and technical persons of LT Mobile Van Inspected the premises of Najimuddin Ansari (User) and held raid.

During raid and inspection it was detected that accused Najimuddin Ansari (User) was using electricity dishonestly by way of tapping the incoming service cable to bypass the proper registration of units in the Energy Meter of WBSEDCL. Through this bypass arrangement he is using 1 Nos. Television , 1 No 100 watt bulb, 5 Nos Tube Light, 4 Nos. Ceiling Fan, 5 No LED Bulb & 1 No Refrigerator having connected load 1.005 KW. The Service Connection of WBSEDCL bearing Consumer ID : 242030339 stands recorded in the name of Abdul Ansari (Lt.) and Najimuddin Ansari is the user of that Service Connection which has been disconnected on detection of theft of Electricity.

I prepared Inspection report in presence of the Accused and assessed the Load as 1.005 Kw. Details have been mentioned in the Inspection Report duly signed by the Accused.

I directed Sri Dayamay Mahato (Sr. T.S.H.) to disconnect the the Service Connection of the above stated Consumer ID. Accordingly he disconnected the aforesaid Service Connection and removed the energy meter along with bypass arrangement.

I prepared seizure list in presence of the accused & witnesses, details of seizure have been mentioned in the seizure list duly signed by the accused. A copy of the seizure list was handed over to the accused. The Local people gathered there witnessed the incident but refused to sign on the Seizure list and inspection report.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offence u/s 135(i)(a) & 135 (i)(b) of Electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused.
