Sub: To lodge FIR

Respected Sir,


I, Shri Udgar Kr. Jha S/O Shrawan Jha of Vill- Rajkumarganj, PS- Darbanga (T) PS, Dist- Darbanga, Bihar, currently working as a contractor under D.R.A.I Pvt. Ltd at Kantadih under Arsha P.S, this is to bring your notice that, on 19.08.2023 at about 22.30 hrs 02(two) persons namely 1. Padmalochan Diger S/O Lt. Ashok Diger & 2. Sachin Digar S/O Kalipada Digar both of Kantadih Basti, PS- Arsha, Dist.-Purulia working under contractor Sri Nemai Dutta, came to my labour hutment at Kantadih Rail over bridge, in drunken condition and assaulted me with iron rod on my head and body without any provocation. Due to the assault, I received grievous injuries on my body & head. I was shifted immediately to Purulia DMGMCH by locals & got admitted. Medical examination revealed that my right hand is fractured & 04 stiches were given on my head.

Their intention was to kill me due to previous grudge regarding firing them from work under me about 3/4 months ago. I got discharged from hospital on 20.08.23.

This incident made all the labourers under me panic stricken & are afraid to work. Therefore, I pray to you to lodge an FIR & take necessary legal action. Delay in lodging FIR due to ongoing medical treatment.
