Sir,

In producing herewith the one accused person namely Sukla Lohar (57 Yrs), S/O-Durgan Lohar of Vill-Raidih, PS- Baghmundi, Dist- Purulia along with seized articles (1) One white colour plastic jerican containing (Approx) 08 (Eight) of ID liquor (2) Plastic disposal glasses 08 (Eight) pieces, (3) 500 ml I.D liquor from Sl No. 1 as sample which were seized under proper seizure list duly signed by the witnesses.

I beg to submit that today on 12.08.2023 during my mobile duty as per Suisa OP C.C No-835/2023 & Suisa OP GDE No-325, Dtd: 12.08.2023 received source information that one person selling ID liquor in his house premises without any valid documents. Accordingly, I SI Saurav Kanti Das along with force (1) C/229 Asit Molla (2) C/2218 Haradhan Lohar, (3) NVF/810 Sakru Mahato all of Suisa OP under Baghmundi PS, Dist-Purulia reached at Raidih village at about 17:55 hrs and found that the above noted person is selling I.D liquor in his house premises. On demand he failed to produce any valid document from competent authority in respect of stocking & selling of ID liquor. In between 18:05 hrs to 18:25 hrs I seized) One white colour plastic jerican containing (Approx) 08 (Eight) of ID liquor (2) Plastic disposal glasses 08 (Eight) pieces, (3) 500 ml I.D liquor from Sl No. 1 as sample from his sole possession U/S- 67 B.E Act which were seized under proper seizure list duly signed by the witnesses. All seized articles were labeled properly in presences of witnesses and accused person. Hence I arrested the above noted person at 18:26 hrs after maintaining all formalities and guidelines regarding arrest. I offered him for medical treatment; but he refused.

The above noted arrested accused person hamely Sukla Lohar (57 Yrs), S/O-Durgan Lohar of Vill-Raidih, PS- Baghmundi, Dist- Purulia committed an offence U/S- 46 (A) (c) B.E Act 1909 for unauthorized possession and selling of ID Liquor from his sole possession.

Under the fact and circumstances, I therefore pray before you a specific case may kindly be started against the above noted accused person under proper section of law and arrange its investigation.
