I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Shankar Kuiry, S/O- Late- Dukhiram Kuiry of Village Lengdih, P.O.- Suisa, PS- Bagmundi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 21/08/2023 at about 12:30 p.m. I Sri Swapan Kumar Das, AE & Station Manager, Bagmundih CCC along with 1. Sri Anup Mondal, JE Gr-I (E), Bagmundi CCC 2. Subhasis Mahato, Sr. O.E. Bagmundi CCC, entered the premises of Sri Shankar Kuiry, S/O- Late- Dukhiram Kuiry of Village Lengdih, P.O.- Suisa, PS- Bagmundi, Dist- Purulia and found Sri Shankar Kuiry was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.30 KVA. As Sri Shankar Kuiry S/O- Late- Dukhiram Kuiry committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Anup Mondal, JE Gr-I (E), Bagmundi CCC 2. Subhasis Mahato, Sr. O.E. . The inspection team left the premises at 12:45 p.m. Dt - 21/08/2023.
