- 1) That the complainant is a permanent of Village Tentlo, P.O. Rangadih, P.S. Balarampur, Dist. Purulia(W.B.) and within the jurisdiction of this Ld. Court.
- 2) That the Accused Persons Shambhu Kumar is the elder brother of the complainant. There is Biri business under the name and style "Sabitri Biri" of the father of the complainant. There is also huge landed properties of his father Bedan Kumar.
- 3) That while said Bedan Kumar died then the complainant was minor and on taking advantage of that the Accused Person grabbed the said Biri business as well as entire properties left by Bedan Kumar.
- 4) That father of the complainant had purchased some properties of his own, but the Accused Person also attempted to grab the entire purchased property of his father in his own name.
- 5) That the complainant protested to the illegal activities and requested to the Accused Person to partitioned all moveable and immoveable properties as well as said Biri business left by Bedan Kumar , but the Accused Person did not pay any heed over the same. On the contrary the Accused Person threatened to the complainant with dire consequence saying that "he would murder the complainant and hi two minor sons as the Accused Person is an Accused Person in a murder case and he known the consequences of law and court case matter ". The Accused Person earns Rs.  $1\frac{1}{2}$  crore to 2 crores per year as well as he

earns Rs. 10 lakhs to 15 lakhs from selling paddy per year. But the Accused Person did not give any share to the complainant.

- 6) That the Accused Person has three sons, out of two sons are Govt. employee and other elder son and the Accused Person run Biri business.
- 7) That the Accused Person runs said Biri business illegally by changing the Brand's name as "Bharat Biri" instead of "Sabitri Biri" which is punishable offence in the eye of law.
- 8) That the Accused Person and his sons also earns more and more money from his business and landed property without paying any income tax to the Govt. The Accused Person also engaged some child labour to his biri business which is also punishable offence in the eye of law. The Accused Person has non-income assets without showing Income Tax return.
- 9) That thus the Accused Person has committed offence by engaging child labour in his biri business as well as he has extended his business and landed properties as non-income assets without paying any Income Tax or other taxes to the Government and the Accused Person attempted to threat to kill the complainant and his minor child as well as he runs his biri business by changing Trade Mark as "Bharat Biri" instead of "Sabitri Biri".

- 9) That the complainant and his family members are passing their days with great fear and anxiety.
- 10) That for proper adjudication the matter and for search and seizure as Police investigation is required in this case.

It is therefore prayed that your Honour will be graciously pleased to send this complaint to the Officer-in-charge, Balarampur P.S. for investigation treating the same as F.I.R. in u/s 156(3) Cr.P.C. for the ends of justice.
