
In producing herewith one arrested accused person namely Uday Majhi (42 Yrs), S/O Lt. Labu Majhi of Village- Mangla, PS- Bandwan, Dist- Purulia with the seized articles i.e. **approx 10 litre illicit distil liquor in 01 white jericin marked as Exhibit "A" & 01 Litre has been taken out in one separate bottles from mother sample as sample marked as Exhibit "B"**. I beg to submit that on 08/08/2023 at about 19.15 hrs. I received a credible source information while I was engaged in Mobile duty that one person namely Uday Majhi (42 Yrs), S/O Lt. Labu Majhi of Village- Mangla, PS- Bandwan, Dist- Purulia is stocking and selling Illicit Distill liquor without any valid license from dwelling house of Uday Majhi (42 Yrs), S/O Lt. Labu Majhi at Village- Mangla, PS- Bandwan, Dist- Purulia. Accordingly, myself along with C/751 Pabitra Patra & C/2420 Suresh Batkar all of Bandwan P.S., Dist-Purulia vide Bandwan P.S. M.C.C. No. 2908/23 Dtd: 08/08/2023 left for Mangla village to work out the said source information and held raid at the dwelling house of Uday Majhi where the above mentioned accused person was stocking and selling Illicit liquor. During search with the help of accompanying force, we found that the above noted person is stocking Illicit Distill liquor for selling. Being asked, he disclosed that all liquor has been stocked for the purpose of selling. On demand, he failed to produce any valid documents/ License in respect of stocking and selling of Illicit Distill liquor. Accordingly, I seized all the Illicit Distill liquor (details in attached seizure list) in between 19:45 hrs to 20.15 hrs and prepared proper seizure list duly signed by the witnesses. **10 litres illicit distil liquor in 01 white jar cane marked as Exhibit "A" & 01 Litre has been taken out in one separate bottle from mother quantity as sample marked as Exhibit "B" and labelled the same.** Then, I arrested him at 20:25 hrs maintaining all legal procedures regarding arrest as laid down by Hon'ble Supreme Court as he committed offence U/S- 46A (C) B.E. Act 1909.

Under the above circumstances and fact, I therefore pray that a specific case may kindly be started U/S 46A(C) B.E. Act 1909 against the arrested accused person namely Uday Majhi (42 Yrs), S/O Lt. Labu Majhi of Village- Mangla, PS- Bandwan, Dist- Purulia and arrange for its investigation.
