I do hereby lodge complaint empowered by enabling The Indian Electricity Act – 2003, subsequently Electricity (Amendment) Act 2007 to the effect that Sri Dhormal Hansda, son of Late Sunil Hansda, vill- Harada, P.O.- Kumra, P.S.- Bundwan, Dist- Purulia was enjoying electricity dishonestly by means of direct hooking from LT line and has committed theft of electricity U/S 135/ 1/a of The Electricity Act 2003.

On 17/08/2023 at about 15:05 Hrs. I, SRI PRASHANTA MANDAL, AE&SM, Bundwan CCC, WBSEDCL.

Along with:

- 1) Sri Maruti Mahato, Junior Engineer, Gr-I, Bundwan CCC, WBSEDCL
 - 2) Sri Anindya Sundar Paul, Office Executive, Bundwan CCC, WBSEDCL
- visited the premises of Sri Dhormal Hansda, son of Late Sunil Hansda, vill- Harada, P.O.- Kumra, P.S.- Bundwan, Dist- Purulia and inspected his premises. During inspection theft of electricity was detected i.e. he was using electricity dishonestly by means of direct hooking.

From the above arrangement he was using the following electrical equipment's:

- 1) 6 Nos of light

Out of which I seized the following:

- 1) 2 core Flexible wire (length approx. 15 m) with hooking device

A seizure list was prepared at the site and the accused person has signed.

The inspection team left the premises at 15:38 hrs. on 17/08/2023.

The accused person has committed an offence U/S 135/ 1/a of The Electricity Act – 2003 & subsequently Electricity (Amendment) Act – 2007.

You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
